AMENDMENT #4

1. BACKGROUND.

- 1.1 Agreement. The Pima County Board of Supervisors (“Board”), the Pima County Recorder (“Recorder”), and the Pima County School Superintendent (“Superintendent”) entered into an Agreement on May 4, 2010, for the use of registration rolls and related elections services.
- 1.2 Term of Agreement. The term of the Agreement began on July 1, 2010, and continued through June 30, 2011. The Agreement was amended on July 2, 2013 to extend it through June 30, 2014. The Agreement may be extended for successive one (1) year terms upon written agreement of the parties.
- 1.3 Fees for Services Provided by the Recorder. Sections 2, 3, and 4 of the Agreement outline specific fees associated with the cost of election-related services and voter registration services provided by the Recorder. The fees provided in the Agreement are in accordance with Pima County Ordinance 2011-44.

2. MODIFICATION OF AGREEMENT.

- 2.1 The Superintendent wishes to extend the Agreement with the Board and the Recorder by one (1) year with a new end date of June 30, 2015.

3. REMAINING AGREEMENT TERMS UNCHANGED. Except as modified as provided in this Amendment, all of the terms and conditions of the Agreement, as amended, shall remain in full force and effect.

4. EFFECTIVE DATE. This Amendment shall be effective as of the date this Amendment is executed by all of the parties hereto.




