Re: FY2024-2025 Recommendation for Returned Funding

## **Background**

On February 25, 2025, Pima County Attractions & Tourism was notified by email that the Tucson City of Gastronomy would be returning their \$15,800 award for the Pueblos del Maiz Festival to be held in April 2025. The federal freeze on funding to nonprofits affected some of their funding streams making the event financially risky to proceed. Upon notification, Attractions & Tourism notified the Outside Agency Citizen Review Committee (OACRC) and recommended the monies be awarded to agencies with a current contract in good standing with events to be held before the end of the current fiscal year.

### **Discussion & Recommendation**

The OACRC met with Pima County Attractions & Tourism staff on Monday, March 24, 2025, for discussion and updates and voted to re-award the funding to two agencies in good standing with events remaining in FY2025.

The Committee voted to award \$7,900 to La Frontera Mariachi Conference for the Tucson Mariachi event to be held April 23-26, 2025. The conference promotes awareness and fosters traditional values of Mariachi and awards scholarships to deserving students.

The committee also voted to award \$7,900 to the Tucson Kitchen Musicians Association for the Tucson Folk Festival to be held April 4-6, 2025, in multiple stages across Tucson with free admission for all.

## Conclusion

The Committee is recommending funding for these two agencies.
