



## BOARD OF SUPERVISORS AGENDA ITEM REPORT

Requested Board Meeting Date: November 20, 2018

**Title:** La Cholla Boulevard No Parking

**Introduction/Background:**

The Pima County Department of Transportation received a citizen request related to vehicles queuing in the paved shoulder on the west side of La Cholla Boulevard south of Orange Grove Road and causing a conflict with bicycles. The vehicular queuing is the result of a drive-thru for a coffee shop.

**Discussion:**

The paved shoulder at this location is approximately 10 feet wide and is utilized by buses, bicycles and right-turning vehicles. Staff set cameras just north of the driveway for a 24-hour timeframe. Vehicles did not queue back onto La Cholla Boulevard during the 24-hour period, but did queue back to the driveway entrance. There is the potential that vehicles queue back into the paved shoulder at different time periods throughout the year and cause a conflict with bicycles.

**Conclusion:**

No Stopping, Standing or Parking, Except Buses regulation for La Cholla Boulevard from Hospital Drive to Orange Grove Road is recommended due to the conflict potential between queued vehicles and bicycles in the paved shoulder. A blanket no parking ordinance, which includes the proposed regulation, is recommended for La Cholla Boulevard. A blanket ordinance in this manner allows the consolidation of existing ordinances and improves the efficiency of posting signs where recommended after study review.

**Recommendation:**

Parking regulation is recommended for the Pima County portions of La Cholla Boulevard in its entirety. Existing Ordinances 1987-141, 1990-071 and 2004-079 are repealed. La Cholla Boulevard from Brittian Drive to Wetmore Road is recommended to be regulated as No Stopping, Standing or Parking anytime, as that is the current field application.

ORDINANCE 2018 - \_\_\_\_\_

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO TRAFFIC AND HIGHWAYS; REGULATING PARKING ON LA CHOLLA BOULEVARD IN PIMA COUNTY, ARIZONA**

**THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA FINDS THAT:**

1. The Board of Supervisors of Pima County, Arizona has authority under A.R.S. § 28-627 and 28-873 as amended, to regulate the stopping, standing or parking of vehicles.
2. The Board of Supervisors has determined that it is in the interest of public safety to establish that vehicles should not stop, stand or park on portions of La Cholla Boulevard.

**BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:**

**SECTION 1.** Parking on both sides of La Cholla Boulevard shall be regulated as the following:

<b>TYPE</b>	<b>FROM</b>	<b>TO</b>
No Parking	Gardner Lane	Wetmore Road
No Stopping, Standing or Parking	Wetmore Road	Brittain Drive
No Parking	Brittain Drive	Hospital Drive
No Stopping, Standing or Parking Except Buses	Hospital Drive	Orange Grove Road
No Parking	Orange Grove Road	200 feet north of Owls Peak Place
No Parking	Limewood Drive	Moore Road

SECTION 2. Ordinances 1987-141, 1990-071 and 2004-079 and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take into effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
