Requested Board Meeting Date: March 21, 2017

**Title:** Wilmot Road - North of Sahuarita Road (RTA-33) - Time Extension of Temporary Road Closure

**Introduction/Background:**

Original Resolution 2016-28 approved by the Board of Supervisors was for a 9 month temporary road closure targeted for July 1, 2016 to April 1, 2017.

**Discussion:**

The actual closure did not go into effect until September 9, 2016. That is when the contract had been executed, the utility relocation activities had been completed, and the impacts of inclement weather had dissipated.

**Conclusion:**

The 9 month closure duration is still needed in order to perform all required work activities.

**Recommendation:**

The Department recommends extending the closure duration until June 30, 2017 in order to allow the remaining work activities to be completed.

**Fiscal Impact:**

Extending the closure duration will avoid increase in project costs and need for additional time.

**RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS PERMITTING THE TEMPORARY CLOSURE OF PORTIONS OF WILMOT ROAD IN PIMA COUNTY, ARIZONA, FOR THE CONSTRUCTION OF A NEW TWO LANE ASPHALT ROAD BETWEEN JULY 1, 2016 AND JUNE 30, 2017**

**WHEREAS**, Pima County Department of Transportation is constructing a new two lane asphalt road to replace the existing dirt road on Wilmot Road from Sahuarita Road to a point 7.1 miles north of this intersection, and

**WHEREAS**, Pima County Department of Transportation has requested the temporary closure of portions of Wilmot Road to facilitate this event, and

**WHEREAS**, the Pima County Board of Supervisors passed Resolution No. 2016-28, authorizing closure of portions of Wilmot Road from Sahuarita Road to a point 7.1 miles north of this intersection between July 1, 2016 and April 1, 2017, and

**WHEREAS**, Pima County Department of Transportation has requested that the temporary closure be extended through June 30, 2017, and

**WHEREAS**, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Wilmot Road to support this event.

**THEREFORE, IT IS HEREBY RESOLVED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** Portions of Wilmot Road between Andrada Road and Old Vail Connection Road shall be temporarily closed to public traffic on July 1, 2016 to June 30, 2017.

**SECTION 2.** Resolution 2016-28 is hereby repealed and replaced with this Resolution.

**SECTION 3.** All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.
