The purpose of the Resolution and Order is to add street intersections on Ina Road from the Canada del Oro Wash to Oracle Road to the list of impact fee eligible projects within the Canada del Oro Benefit Area. Intersection improvements along this segment of roadway will allow for increased capacity along Ina Road. Currently, this segment of Ina Road is congested and intersection improvements will improve traffic flow in this area.

**A RESOLUTION OF THE BOARD OF SUPERVISORS OF  
PIMA COUNTY, ARIZONA, RELATING TO CAPITAL  
IMPROVEMENTS FUNDING WITHIN DEVELOPMENT  
FEE BENEFIT AREAS; ADDING ALL INA ROAD  
INTERSECTIONS BETWEEN THE CANADA DEL ORO WASH  
AND ORACLE ROAD TO THE ELIGIBLE PROJECTS LIST  
FOR THE CANADA DEL ORO BENEFIT AREA.**

**WHEREAS**, on April 8, 2003, the Pima County Board of Supervisors adopted Pima County Ordinance No. 2003-40 which amended Pima County Code Chapter 19.03 relating to Roadway Development Impact Fees by establishing new non-residential fees, increasing existing residential fees, adding Roadway Development Impact Fees within newly designated benefit areas, and adopting a schedule of projects to be funded in whole or part by Roadway Development Impact Fees, and

**WHEREAS**, on January 6, 2009, the Pima County Board of Supervisors adopted Pima County Ordinance No. 2009-02 which identifies specific eligible roadway construction projects within each Benefit Area along with the total estimated cost of each project in 2008 dollars, and

**WHEREAS**, the Board has determined that in order to provide for the proper flow and circulation of traffic it is necessary to modify the list of impact fee projects identified in the Canada del Oro Benefit area, and

**WHEREAS**, the Board has considered the advantages of including the intersections on Ina Road between the Canada del Oro Wash and Oracle Road as eligible roadway construction projects within the Canada del Oro Benefit Area,

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF  
SUPERVISORS OF PIMA COUNTY, ARIZONA, THAT:**

**SECTION 1.** The intersections on Ina Road at Shannon Road, La Cholla Blvd, La Canada Drive and Oracle Road shall be added to the list of impact fee eligible projects within the Canada del Oro Benefit Area.

**SECTION 2.** The various Pima County officers and employees are hereby authorized and directed to perform all acts necessary and desirable to give effect to this Resolution.






