**Requested Board Meeting Date:** April 19, 2016

**Title:** Ordinance to Regulate Traffic at Casas Serenas Drive and Fellows Avenue

### **Introduction/Background:**

The Pima County Traffic Engineering Division received a citizen request for the installation of a stop sign at the intersection of Casas Serenas Drive and Fellows Avenue. The citizen indicated that several near misses have been observed at the intersection.

### **Discussion:**

As a result of the request, a study was conducted at the intersection to determine if regulatory traffic control was warranted.

### **Conclusion:**

The intersection study determined that stop control is warranted for westbound vehicles on Casas Serenas Drive at Fellows Avenue due to sight distance restrictions.

### **Recommendation:**

The Pima County Traffic Engineering Division recommends that a stop sign be installed for westbound Casas Serenas Drive at Fellows Avenue based on the results of the intersection study in order to reduce potential vehicular conflicts.

**ORDINANCE NO. 2016-\_\_**

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF  
SUPERVISORS REGULATING TRAFFIC AT THE  
INTERSECTION OF CASAS SERENAS DRIVE AND  
FELLOWS AVENUE IN PIMA COUNTY, ARIZONA**

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-855 as amended, to designate and establish stop intersections and to erect stop signs, and

**WHEREAS**, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public of Pima County, Arizona, to establish the intersection of Casas Serenas Drive and Fellows Avenue as a stop intersection,

**THEREFORE, IT IS HEREBY ORDAINED** by the Board of Supervisors of Pima County, Arizona, that:

**SECTION 1.** The intersection of Casas Serenas Drive and Fellows Avenue shall be designated a stop intersection with westbound traffic on Casas Serenas Drive stopping for traffic on Fellows Avenue.

**SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

**SECTION 3.** This ordinance shall take effect when and to the extent that stop or yield signs are posted on the intersecting streets.

**SECTION 4.** Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

**SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.




