

Re: Limited Competition approval for Professional Services for the Accela Permitting system

Pima County Information Technology Department is requesting Limited Competition approval for professional services provided by TruePoint Solutions, Inc. that includes the following items and services:

- Accela Training – Configuration, Scripting, Reporting and Testing
- Configuration Services – Configuring new or enhancing current record Types
- Scripting Services – Automation & scripting services for new and existing Record Types
- Reporting Services – Developing new or enhancing reports & letters
- Integration Services – Developing new or enhancing current system integrations
- Analysis Services – Analyzing and documenting existing or To-Be business processes in relation to Accela permitting
- Testing Services – Develop test plans, test cases and perform unit, system and UAT testing
- Provide industry expertise and best practices on the Accela platform
- Consistent and accessible Accela system expertise that remains current with the changes and enhancements at Pima County

Pima County is in need of consistent and competent staff and project augmentation for the Accela Permitting system. Currently we have challenges that require professional services to aid the Pima staff in the timely completion of the LPM project (system testing). This current need and the projected growth of the Accela system after go-live require that we have the flexibility to bring in contracted professional services when needed in order to meet the demands of the business. Keeping sufficient trained and experienced Accela professionals on staff will always be a challenge so we must have a business partner we can turn to quickly when we are in need of training or additional resources to meet project or support demands.

Accela Inc, that we are currently contracted with for the implementation of LPM has a business model that is focused on large initial deployments and does not "stay with" the changes to the system after go-live nor are they able to provide timely assistance with small to medium sized projects. Accela has no local presence and contracts with business partners like TruePoint Solutions to do any type of smaller projects after initial implementation. In the case of our immediate needs for system testing, using Accela resources would represent a conflict of interest as we would be asking them to test their own deliverables.

TruePoint Solutions, Inc. is a local certified Accela implementation partner that is used by many cities, states and counties around the country. TruePoint Solutions has been the provider of advanced technical training to Pima IT staff and has intimate knowledge of our implementation and our technical staff. They have provided not only Accela expertise, but excellent customer service and have responded quickly to Pima County's needs.
