WHEREAS, Mark Stevens has been an avid proponent and advocate in promoting youth baseball/softball in Pima County and the surrounding areas for over a decade:

WHEREAS, Mark Stevens became a board member of the Canyon View Little League organization and served in various capacities during his tenure;

WHEREAS, Mark Stevens served as president of the Canyon View Little League and led the organization with integrity and with an eye towards developing the skills of boys and girls who enjoyed baseball or softball, and now serves as head coach for the Catalina Foothills varsity Softball Team;

WHEREAS, the Board of Supervisors of Pima County finds that Mark Stevens is exceptionally worthy of recognition and wishes to name the Mehl Park Field #3 as Mark Stevens Field in his honor;

NOW, THEREFORE, the Board of Supervisors of Pima County resolves that:

The Mehl Park Field #3 is hereby named as the *Mark Stevens Field*, and the Pima County Natural Resources, Parks and Recreation Department is hereby authorized and directed to take the actions necessary to give effect to this resolution, including the installation of new signage at the park, updating maps and publications as appropriate, and advising the media and the community of the naming and the reasons for this action.
