**Repeal of
Bond Implementation Plan Ordinance No. 2015-37
for the 2015 Bond Election**

Background

Pursuant to Pima County Code, Chapter 3.06, the Board of Supervisors is required to adopt by ordinance a detailed bond implementation plan (Bond Ordinance) for each bond election. The overall intent of the Bond Ordinance is to provide voters, prior to early voting, with detailed information on the proposed bond projects, as well as the estimated impacts to secondary property taxes from the sale of the bonds. On September 15, 2015 the Board held a public hearing and approved the detailed 167 page Bond Ordinance No. 2015-37 for the November 3, 2015 election. Voters did not approve the seven bond propositions. Therefore, it is necessary to repeal Ordinance No. 2015-37. Because it is an ordinance, a public hearing is required. The public hearing has been scheduled for the Board's December 1, 2015 meeting. Notice of the hearing was published in the Daily Territorial on November 13 and the Arizona Daily Star on November 15. Recommendation

I recommend the Board repeal the Bond Implementation Plan Ordinance No. 2015-37 previously adopted for the November 3, 2015 bond election.

**AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA,
REPEALING THE BOND IMPLEMENTATION PLAN ORDINANCE FOR THE 2015
BOND ELECTION**

The Board of Supervisors of Pima County, Arizona finds that:

1. The Board of Supervisors of Pima County, Arizona, on April 21, 2015, passed Resolution #2015-19, which set a special bond election for November 3, 2015, and adopted 7 bond propositions to be submitted to the voters at that election.
2. The Board, pursuant to Pima County Code Chapter 3.06, on September 15, 2015, adopted Ordinance #2015-37, the bond implementation plan for the 2015 bond election propositions.
3. Because the voters did not approve any of the bond propositions at the special bond election, the bond implementation plan ordinance is no longer needed.

SECTION 1. Ordinance #2015-37, adopted September 15, 2015, is hereby repealed in its entirety.
