**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The reason for this resolution is that On Your Left Fitness has requested the temporary closure of portions of La Canada Drive from Calle Concordia to Rancho Feliz Drive and Calle Concordia from La Canada Drive to Calle Loma Linda for the Oro Valley Sprint Tri & Du Festival event on March 24, 2018 from 6:00 A.M. to 2:00 P.M.

**Discussion:**

As a result of the request and Special Event Permit Application review, Pima County Traffic Engineering recommends the temporary closure of portions of La Canada Drive from Calle Concordia to Rancho Feliz Drive and Calle Concordia from La Canada Drive to Calle Loma Linda.
