**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

Country Fair White Elephant, Inc. has requested the temporary closure of portions of La Canada Drive and Esperanza Boulevard for the Country Fair White Elephant Parade event on Saturday, October 26, 2019 from 9:00 A.M. to 1:00 P.M.

**Discussion:**

After review of the request, Pima County Transportation recommends the temporary closures to enhance the safety of the Country Fair White Elephant Parade event by reducing potential vehicular conflicts.

**Conclusion:**

Pima County Transportation recommends the temporary closure of portions of La Canada Drive from San Ignacio to Calle Lecho and Esperanza Boulevard from Camino del Portillo to Interstate 19 to enhance the safety of the Country Fair White Elephant Parade event by reducing potential vehicular conflicts. A full road closure on La Canada Drive will be in effect from Paseo del Prado/Calle de las Casitas to Desert Bell Drive/La Canoa and on Esperanza Boulevard from Las Yucas to Paseo Pena.
