



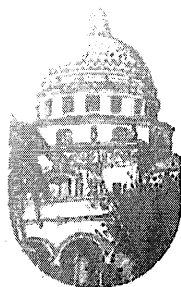

County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$295,000.00. This payout increase is effective as of 11/08/21.
