Tax Sale TS-0054 Lot 36 of Rocking K Ranch Estates II

*Introduction/Background:

Resolution for the sale of land conveyed to the State of Arizona under a Treasure's Deed, to Fabian Gonzalez

*Discussion:

On January 4th, 1983, tax parcel 205-81-0490 (the "Property") was conveyed by Treasurer's Deed to the State of Arizona due to Outstanding delinquent taxes. The Property is an approximately 3.43 acre site of vacant land located in the Rocking K Ranch Estates II subdivision, with an address of 7111 S. Plaza De Cardenal. The sale of the Property is pursuant to ARS 42-18303, to the highest bidder, which is Fabian Gonzalez.

*Conclusion:

The Pima County Treasurer's office will receive revenue for Property conveyed to the state for delinquent taxes, and the property will be restored to the tax roll.

*Recommendation:

It is recommended that the Board of Supervisors approve the Resolution authorizing the sale of the Property to Fabian Gonzalez

*Fiscal Impact:

Pima County Treasurer will receive funds for property that has been conveyed to the State for delinquent taxes consisting of a sales price of \$62,200.00 plus an administrative fee to Real Property Services of \$750.00, for a total of \$62,950.00
