Discussion:

Approval of these waivers would allow the Assessor's Office to process exemptions for qualified property owners who have missed the March 1st deadline, but have otherwise shown that they meet necessary requirements in A.R.S. 42 Article 3. 42-11101-42-11155

Conclusion:

Individuals and/or non-profits who meet the requirements of A.R.S. 42 Article 3-"Exemptions" would be granted Exemptions after the March 1st deadline.

Recommendation:

Approve redemption of waiver of exemption deadline as provided in A.R.S. 42-11153(B)
