Dear County Administrators,

Your appointment of Jake Martin for Pima County Treasurer deserves careful consideration. The Treasurer is responsible for safeguarding and investing public funds, collecting property taxes, managing cash flow, and ensuring the county's finances are handled responsibly. These responsibilities require financial knowledge, sound judgment, and the ability to manage a complex public office.

Jake Martin, was appointed Chief Deputy Treasurer in November 2024 at age 21 after Brian Johnson was elected Treasurer. Before joining the Treasurer's Office, Martin was a University of Arizona student who ran for the District 1 Board of Supervisors seat during the 2024 Democratic primary. His bachelor's degree is in Human Development and Family Studies.

During his Board of Supervisors campaign, Martin's platform emphasized expanding access to healthcare and social services. Those priorities are appropriate subjects for debate in legislative offices such as the Board of Supervisors. However, the Treasurer's Office has a much different mission. Its primary responsibility is protecting, investing, and managing taxpayer funds—not developing public policy or advocating for social programs.

As a taxpayer, I believe the Board should focus first on candidates with substantial financial experience, investment knowledge, cash management expertise, and a demonstrated record of managing large public budgets. The Treasurer oversees billions of dollars in county funds, and the position requires technical financial competence as much as administrative leadership.

I also noticed that several letters supporting Mr. Martin's application came from employees within the Treasurer's Office, while former Treasurer Beth Ford submitted a recommendation supporting another applicant, Derika Louk. Board members should carefully review every applicant's qualifications, work history, education, management experience, and letters of recommendation before making this important appointment.

This decision should not be based on politics, ideology, or campaign experience. It should be based on who is best prepared to fulfill the statutory responsibilities of the County Treasurer and protect the financial interests of Pima County taxpayers.

You should encourage residents to review the applicants' resumes and letters of interest before making

this commitment. An informed public makes for better government, and this appointment will have lasting consequences for the stewardship of nearly \$2 billion in county funds.
