Social Services Block Grant (SSBG)

*Purpose:

SSBG will be used to provide employment services to eligible Pima County residents. Services include job training for programs that have a demand for skilled job opportunities, GED preparation, pre-vocational training, and case management to ensure graduation and job placement. Services are intended for single head of households, unemployed adults, elderly, low-income adults, youth 18-28 years of age at risk of homelessness, families and rural adults. This amendment is to provide revenue funding of \$40,891.00 for SFY2022.
