To the Board of Supervisors,

In the interest of brevity, I am going to assume that we're all on the same page in understanding that;

- 1. Covid is a real, airborne virus that has killed over 18,000 Arizonans and left countless others with long haul illness
- 2. masks work to reduce some of the spread of the illness,
- 3. children can suffer illness and death from covid, and can also spread the virus, and
- 4. most major medical and public health organizations are now recommending indoor mask wearing in schools.

If we want to reduce the spread of Covid and avoid a new, pediatric pandemic, then Pima County must mandate masks in schools. Without a requirement from the state or county, some school districts will not institute any mitigation measures. Kids who are ineligible for the vaccine will be especially at risk, and community spread will affect all of us. Please allow my experience as described below to be an example of a school district not instituting any meaningful covid mitigation protocol without a county mandate.

My 11-year-old son and I attended 6th grade orientation at Cross Middle School, in Amphitheater School District, on July 30th. I was disheartened to see that the principal and most staff and children were not wearin masks, even though most 6th graders are ineligible for the vaccine. They also did not make any effort to distance the kids. I wrote a letter to the principal, superintendent, and school board, asking them to consider wearing/enforcing masks to protect the 6th graders.

On August 4th, the day before school started, Superintendent Jaeger sent out a letter acknowledging that covid is spreading and encouraging masks because they work, but also stating that we can choose not to wear masks and everyone's choices will be supported. Later that day, I received a call from the principal to advise that a kid in my son's tour group at orientation had come down with covid. We hadn't even made it to the first day of school, and my son was already being notified of exposure.

The principal advised that the purpose of his call was just an FYI to watch out for symptoms. He said that they do not require exposed kids to be quarantined or tested, and I was free to send my son to the first day of school without a mask should I so desire. He noted that a couple of the parents said they might get their kids tested, but the rest weren't really concerned.

What is the point of tracking exposures if we're not going to take any corresponding mitigation actions? This is essentially the same as doing nothing. Amphi's lack of meaningful covid protocol is highly irresponsible in my opinion.

I ran to Walgreens and purchased some instant covid tests. My son was fortunately negative, and experiencing no symptoms, so I did send him (masked) to his first day of school. Despite the superintendent's letter encouraging masks, my son noted that his teachers and most classmates were still not wearing masks. On Friday, my son counted 3 other kids wearing masks, and no teachers.

Please institute a mask mandate for Pima County schools. I understand that there are some parents who don't want their children to have to wear a mask. But the risk of illness, death, community spread and overtaxed hospitals heavily outweighs this concern. The likely consequence of not enforcing masks in schools is just far too great.

Dear Pima County Supervisors:

I am writing to you as a concerned parent, community member and constituent, to thank you for adding Resolution of the Pima County Board of Supervisors Mandating the Use of Face Coverings in All K-12 Schools Within the County, as an Effective Mitigation Strategy to Keep our Children Safe from COVID-19; Effective Immediately to the Pima County Addendum Agenda for 8/10/21. I urge Pima County Supervisors to vote in favor of the County Resolution requiring a universal mask requirement in K-12 schools.

Arizona is currently experiencing another COVID-19 surge, with cases having tripled over the past month, coinciding with the arrival of the <u>highly contagious</u> SARS-CoV-2 delta variant in the state. States all over the country are seeing an increase in cases among the unvaccinated, and this includes a drastic increase in child hospitalizations, many of whom are not yet eligible for vaccination. The Academy of Pediatrics recently reported that <u>cases among US children</u> and teens jumped 84% in a week.

According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to <u>data</u> published recently by the American Academy of Pediatrics.

Schools began welcoming back students to campus late last month and are already experiencing outbreaks across the state. Many are being forced back to online learning because they are not able to use simple mitigation tools like universal masking. The science around masking is settled. Masks work to prevent disease transmission. All recent public health agencies, both national and local, have issued statements recommending universal masks for K-12 students in schools. Arizonans have a right to safe schools for Arizona kids. Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law passed by the state banning schools from implementing such policies is likely unconstitutional, [2] doesn't take effect until Sept. 29 and poses a serious risk to life and health.

Please choose to stand with our children and Arizona communities in supporting a safe return to the classroom by adopting the Resolution requiring masks in K-12 schools.



An August 9, 2021 article by Dr Marty Makary, professor at Johns Hopkins School of Medicine, and Dr. Cody Meissner, chief of pediatric infectious diseases at Tufts Children's Hospital; bring real science to the question of masks for children. To Whom It May Concern.

I'm opposed to the mask mandate for K-12.

You are all in violation of our parental rights under ARS 1-601 and 1-602. Take a stand against child abuse!

ARS 8-201:

This establishes the legal definition of "abuse" in state law. It reads:

"Abuse" means the infliction or allowing of physical injury, IMPAIRMENT OF BODILY FUNCTION of disfigurement or the infliction of or allowing another person to CALISE SERIOUS EMOTIONAL. disfigurement or the infliction of or allowing another person to CAUSE SERIOUS EMOTIONAL DAMAGE as evidenced by severe anxiety, depression, withdrawal or untoward aggressive behavior and which emotional damage is diagnosed by a medical doctor or psychologist and is caused by the acts or omissions of an individual who has the care, custody and control of a child.

School districts across Arizona are being permitted to violate state statute and abuse our children with impunity.

Unlike violations of the parents rights statutes, there are real and serious consequences for committing the crime of child abuse.

### ARS 13-3623:

Under circumstances other than those likely to produce death or serious physical injury to a child, any person who causes a child to suffer physical injury or ABUSE or, having the care or custody of a child, who causes or permits the person or health of the child to be injured or who causes or permits a child to be placed in a situation where the person or health of the child is endangered is guilty of an offense as follows:

- 1. If done intentionally or knowingly, the offense is a class 4 felony.
- 2. If done recklessly, the offense is a class 5 felony.
- 3. If done with criminal negligence, the offense is a class 6 felony.

It goes on to state that, "Abuse", when used in reference to a child, means abuse as defined in section 8-201.

FYI: BREATHING IS A CRITICAL BODILY FUNCTION AND MASKS COVERING THE NOSE AND MOUTH IMPAIRS IT!!

Officials in our state have turned a blind eye to this and allowed our children to literally be abused in the name of "protecting others." We cannot continue to allow children to be sacrificed to provide a false sense of security to adults that refuse to accept scientific data and evidence. Abusing children so that some people can "feel better" is not acceptable... EVER. Not even in a "pandemic".

The school district governing board members that vote to continue mask requirement policies and district staff that enforce mask wearing by children must be charged accordingly, TO THE LETTER OF THE LAW. Good evening -

This email may be too late, but I'll write in anyway.

I'm writing to ask that the Pima County Board of Supervisors approve a mask mandate in Pima County public schools.

I am a vaccinated certified staff member at a K-5 elementary school and am one of the few staff members wearing my mask all day.

I experienced the last quarter remote schooling in the 2019-20 school year and the remote, hybrid, remote, hybrid, in-person schooling from last year, and am THRILLED to be back on campus with our students this school year. HOWEVER, I firmly believe that for this to be able to continue, students and staff MUST be wearing masks, practicing good hygiene, and cleaning protocols while on campus. In my position, during the first couple weeks of school, I provide support for parent drop off and pick up and mainly focus my time in getting kindergarten students acclimated to school. With this, I've been supporting their teachers by working with these students individually to assess the skills they have coming into kindergarten.

These are my observations from the past few school days.

- 1 Morning drop-off about 30% of students exiting cars and entering school with their mask on
- 2 Afternoon pick-up about 10% of students exiting school with their mask on
- 3 Kindergarten classrooms about 15% of students are wearing masks
- 4 Kindergarten students I've assessed one:one, sitting at a small table- I'm masked, most students not masked, many students with fingers in mouth, eyes, face, touching my materials, etc. etc.. When I worked with kinder students in-person last year, they had to wear masks. This made the fingers in mouth/nose much less frequent. Students coughing or sneezing in classrooms some into their arms (YAYIII), and many not.
- 5 Kids interactions with each other often have to remind them to give each other space as they are in each other's faces often...right up in each other's faces

So much of the behavior noted above is expected and normal for our children, but all I know after what I experienced working with students remotely (reading interventions are so hard to do this way), is that we CANNOT go back to remote schooling. We have to do whatever we can to keep our students and staff healthy and safe and IN SCHOOL in our buildings.

I am so disheartened that we are here. I am doing everything I can to help keep students safe and healthy at my school, but I know it is not enough. There are not enough of us doing what we need to be doing. The limited amount of "do righters" can't keep this up when they are outnumbered by the "do wrongers". If we don't get masks mandated in schools, we will be back to remote, and we just can't go there again. We can't. The majority of students do not thrive with this type of learning. They need to be at school, in-person, in the building, wearing masks

### To Whom It May Concern:

I am a local doctor in Tucson writing to express my great concern regarding the impending vote on county vaccine mandates, as well as for masks for children in schools. First of all, neither vote should not even be under consideration, as it has already been deemed illegal at the state level. Article 4.2, Section 36-681 of SB1824 states, "NOTWITHSTANDING ANY OTHER LAW, THIS STATE AND ANY CITY, TOWN OR COUNTY OF THIS STATE ARE PROHIBITED FROM ESTABLISHING A COVID-19 VACCINE PASSPORT OR REQUIRING EITHER OF THE FOLLOWING: 1. ANY PERSON TO BE VACCINATED FOR COVID-19. 2. A BUSINESS TO OBTAIN PROOF OF THE COVID-19 VACCINATION STATUS OF 2 ANY PATRON ENTERING THE BUSINESS ESTABLISHMENT. 3 B. ANY LAW OR ORDINANCE ESTABLISHING A COVID-19 VACCINE PASSPORT IS VOID AND IS NOT ENFORCEABLE AGAINST ANY PERSON OR BUSINESS LOCATED IN THIS STATE."

Additionally, HB2898 states, "NOTWITHSTANDING ANY OTHER LAW OR ORDER, A COUNTY, CITY, TOWN, 5 SCHOOL DISTRICT GOVERNING BOARD OR CHARTER SCHOOL GOVERNING BODY MAY NOT 6 REQUIRE THE USE OF FACE COVERINGS BY STUDENTS OR STAFF DURING SCHOOL HOURS 7 AND ON SCHOOL PROPERTY."

Beyond the legal arguments, however, the vaccine mandates do not make scientific sense. I am writing in support of the mandatory masking for K-12 agenda item up for consideration tomorrow morning.

As a parent of two children in schools in Pima County, I am extremely concerned about the Delta variant and how it is impacting children. This variant is stronger and has led to an increase in the number of pediatric admissions, something that wasn't seen with the previous COVID variants. Multiple members of the health community are concerned about this trend, especially since the majority of children are unable to be vaccinated at this point. More than 18% of the new cases in Pima County since July 1 are in people 16 and younger. Just today, the American Academy of Pediatrics wrote a letter to the FDA urging them to approve the vaccine for 5-12 year olds due to the pressing risk the Delta variant carries. Until this happens though, masking is the easiest thing we can do to protect our children.

We have seen, in multiple school districts across the state, that a "recommended" policy simply does not work. Ellsworth Elementary has already moved 5th & 6th graders to online learning due to an outbreak. Also, reviewing the Maricopa County COVID-19 School dashboard, most areas are experiencing substantial transmission. This is just after two weeks of being in school. With the start of school today, we have the opportunity to not put our students at the same risk with the passage of a mask mandate.

Tucson Unified District has already passed a mask mandate, along with several other districts throughout the state, including Phoenix Union and Madison School District. They decided that the health and safety of our children supersedes a law based in politics -- as a way to secure Republican passage of an unnecessary tax cut -- and not science. ARS 8-201, establishes the legal definition of "abuse" in state law. It reads; "Abuse" means the infliction or allowing of physical injury, IMPAIRMENT OF BODILY FUNCTION or disfigurement or the infliction of or allowing another person to CAUSE SERIOUS EMOTIONAL DAMAGE as evidenced by severe anxiety, depression, withdrawal or untoward aggressive behavior and which emotional damage is diagnosed by a medical doctor or psychologist and is caused by the acts or omissions of an individual who has the care, custody and control of a child.

School districts across Arizona are being permitted to violate state statute and abuse our children with impunity. Unlike violations of the parents rights statutes, there are real and serious consequences for committing the crime of child abuse.

ARS 13-3623

Under circumstances other than those likely to produce death or serious physical injury to a child, any person who causes a child to suffer physical injury or ABUSE or, having the care or custody of a child, who causes or permits the person or health of the child to be injured or who causes or permits a child to be placed in a situation where the person or health of the child is endangered is guilty of an offense as follows:

- 1. If done intentionally or knowingly, the offense is a class 4 felony.
- 2. If done recklessly, the offense is a class 5 felony.
- 3. If done with criminal negligence, the offense is a class 6 felony.

It goes on to state that,

"Abuse", when used in reference to a child, means abuse as defined in section 8-201.

FYI: BREATHING IS A BODILY FUNCTION AND MASKS COVERING THE NOSE AND MOUTH IMPAIRS IT Officials in our state have turned a blind eye to this and allowed our children to literally be abused in the name of "protecting others." We cannot continue to allow children to be sacrificed to provide a false sense of security to adults that refuse to accept scientific data and evidence. Abusing children so that some people can "feel better" is not acceptable... EVER. Not even in a "pandemic".

Dear Pima County Supervisors:

I am writing to you as a concerned parent asking that you adopt a County Resolution requiring universal masking in K-12 schools within county boundaries.

On Tuesday, August 10, 2021 Pima County is considering a Resolution of the Pima County Board of Supervisors Mandating the Use of Face Coverings in All K-12 Schools Within the County, as an Effective Mitigation Strategy to Keep our Children Safe from COVID-19; Effective Immediately.

I urge Pima County Supervisors to vote in favor of the County Resolution requiring a universal mask requirement in K-12 schools.

Arizona is currently experiencing another COVID-19 surge, with cases having tripled over the past month, coinciding with the arrival of the highly contagious SARS-CoV-2 delta variant in the state. States all over the country are seeing an increase in cases among the unvaccinated, and this includes a drastic increase in child hospitalizations, many of whom are not yet eligible for vaccination. The Academy of Pediatrics recently reported that cases among US children and teens jumped 84% in a week.

According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to data published recently by the American Academy of Pediatrics.

Schools began welcoming back students to campus late last month and are already experiencing outbreaks across the state. Many are being forced back to online learning because they are not able to use simple mitigation tools like universal masking. The science around masking is settled. Masks work to prevent disease transmission. All recent public health agencies, both national and local, have issued statements recommending universal masks for K-12 students in schools.

Arizonans have a right to safe schools for Arizona kids. Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law passed by the state removing local control and banning schools from implementing such policies is likely unconstitutional, doesn't take effect until Sept. 29 and poses a serious risk to life and health.

Please choose to stand with our children and Arizona communities in supporting a safe return to the classroom by adopting a County Resolution requiring masks in K-12 schools as soon as possible.

To my Pima County Board of Supervisors,

Please pass Resolution No 2021-49 and mandate masks in K-12 schools in Pima County. I nearly wept with relief when I saw that you were considering mask mandates in our county schools - thank you. I beg that you pass this important resolution with immediate effect.

In light of the information summarized by Dr. Katelyn Jetelina attached below, the CDC's recent guidance update and endorsement by the American Academy of Pediatrics that everyone should wear masks indoors, and the importance of providing a safe learning environment for students and teachers, please mandate masks in our schools. We must take back our authority to make science-informed decisions for the safety of our students, in accordance with changing conditions and CDC guidelines.

I am a parent but I am also an experienced biologist who understands the science. Masks work, are a simple but effective measure, and are absolutely required right now. As a community, we must all work together to protect our neighbors and especially our unvaccinated children. My daughter is a bright and energetic girl who attended remote kindergarten for a full year last year in the Marana Unified School District, and I have been thus far impressed and comforted by the excellent handling of this unprecedented situation by the school and its teachers. But when I dropped her off for the first day of inperson school last week, my heart sank to see so many people unmasked, including her new teacher. I have no way of knowing if her teacher is even vaccinated - and even if so, we are now learning that the Delta variant can still be carried and passed on by vaccinated people. With the majority of kids and teachers maskless, the peer pressure my daughter will feel to take hers off will be greater. So far, she loves wearing her masks and enjoys matching them to her outfits - proof that kids can learn and normalize wearing masks the same as they learn to wear socks with their shoes. But that is not enough protection if others fail to do their part.

Our children need in-person school for their own mental health, and working parents are also trapped by the inability to provide homeschooling. Virtual schooling is not even an option at her school right now, and as difficult as it was for us last year to accomplish at least it was safe. We need safe learning environments for our kids at school. Vaccination for my 6-year-old, and her 3-year-old brother, will not happen before we see another wave as the Delta variant has already started to take hold in Pima County. The measures of MUSD's Health Mitigation Plan are excellent, but fall critically short by not mandating masks - a stance they have told me they will not change thanks to Gov. Ducey's harmful and unconstitutional legislation. I recognize that this has become a politicized issue, and you all are able to cover your inaction by saying your hands are tied. But I desperately hope you will take a braver and more ethical stand for our children and community. In the end, mask and vaccination mandates may be

The Centers for Disease Control and Prevention and the American Academy of Pediatrics strongly recommend that order for schools to remain open, which is of critical importance to the education and wellbeing of children and families, certain public health measures must be instituted and adhered to, like universal mask wearing.

## Delta has changed the game • Delta is 200% more transm

- Delta is 200% more transmissible and results in up to 1000x higher viral load compared to previous variants.
- This translates into a R(0)=6-10. Meaning, on average, one person infects 6-10 peo
  This is similar to the R(0) for chickenpox and higher than the R(0) for smallpox.

#### Not enough kids are protected for an effective immunity wall

#### Study after study shows the effectiveness of a layered approach in K-12 schools

- In Missouri, schools that implemented masks, physical distancing, and increased ventilation had much lower transmission than in the community (Dawson et al., 202)
- In Utah, despite high community incidence and an inability to space students<sup>n</sup> classroom seats ≥6 ft apart, high student mask use resulted in low transmission and no school-related outbreaks in 20 Salt Lake County elementary schools (Hershow et al., 2021)
- In rural Wisconsin, masking requirements and student cohorting within schools allowed transmission risk to remain low (Falk et al., 2021)
- A study in Florida found a layered approach is especially needed when community spread is high (Doyle et al., 2021)

#### COVID-19 in kids can range from mild to severe illness

- As of July 22, 2021, over 4.1 million COVID-19 pediatric cases have been reported.
   The CDC estimates that the "true" burden is 26,838,244 pediatric cases in the U.S.
- In 23 states, 16,878 pediatric hospitalizations have been reported. The CDC estima-209,264 cumuative pediatric hospitalizations in the U.S. as a whole.
  - · Hospitalization rates for COVID-19 are higher than for the 2009-10 H1N1 panden
- As of May 2021, 3,742 MIS-C cases have been linked to COVID-19.
- Over 400 pediatric deaths have been reported since the beginning of the pandemic.
   Although this seems low compared to adults, COVID-19 is now a top 10 cause of death for adolescents in the United States.
- Mortality is not the only negative outcome. Long COVID-19 (or Post-acute Sequelae COVID-19 [PASC]) has been reported among kids.
  - The British National Health Service is reporting that 7-8% of kids experience long COVID-19 and is opening new pediatric clinics for long COVID-19 around the country.

#### We need to stop transmission among kids to stop spread in the community.

- Kids spread SARS-CoV-2 as efficiently as adults. Several outbreak investigations hav demonstrated transmission among children, adolescents, and young adults, including transmission to older household members.
- Living with a child engaged with in-person school without public health mitigation measures increases the odds of COVID-19 for the household (Lessler et al., 2021)
- Children who got COVID-19 at two Utah daycares spread it to household members (Schwartz et al., 2020)

### o a contactive approach is far more effective than an individualistic approach

- While masks provide protection to the wearer, they primarily serve as source control
  and the greatest benefits occur if everyone wears them.
- Kids are highly influenced by peers and teachers. If all peers are required to wear masks, social desirability will play a factor into compliance.
- Using vaccination status to determine who should wear a mask in schools will be a hi burden on teachers and staff and nearly impossible to enforce

Masking Children: Tragic, Unscientific, and Damaging

Children do not readily acquire SARS-CoV-2 (very low risk), spread it to other children or teachers, or endanger parents or others at home. This is the settled science. In the rare cases where a child contracts Covid virus it is very unusual for the child to get severely ill or die. Masking can do positive harm to children – as it can to some adults. But the cost benefit analysis is entirely different for adults and children – particularly younger children. Whatever arguments there may be for consenting adults – children should not be required to wear masks to prevent the spread of Covid-19. Of course, zero risk is not attainable – with or without masks, vaccines, therapeutics, distancing or anything else medicine may develop or government agencies may impose.

For the below reasons there is absolutely NO reason children should receive the covid shot. Based on studies done by Professor John PA loannidis of Stanford University, we know that we are dealing with a virus that has an infection fatality rate (IFR) of 0.05 in persons 70 years old and under (range: 0.00% to 0.57% with a median of 0.05% across the different global locations; with a corrected median of 0.04%). This compares quite well to the IFR of most influenza viruses (and even lower), and yet the draconian and massive reactions to SARS- CoV-2 have never been employed during influenza season.

Dear Pima County Supervisors:

I am writing to you as a concerned parent to thank you for adding Resolution of the Pima County Board of Supervisors Mandating the Use of Face Coverings in All K-12 Schools Within the County, as an Effective Mitigation Strategy to Keep our Children Safe from COVID-19; Effective Immediately to the Pima County Addendum Agenda for 8/10/21.

I urge Pima County Supervisors to vote in favor of the County Resolution requiring a universal mask requirement in K-12 schools.

Arizona is currently experiencing another COVID-19 surge, with cases having tripled over the past month, coinciding with the arrival of the <u>highly contagious</u> SARS-CoV-2 delta variant in the state. States all over the country are seeing an increase in cases among the unvaccinated, and this includes a drastic increase in child hospitalizations, many of whom are not yet eligible for vaccination. The Academy of Pediatrics recently reported that <u>cases among US children</u> and teens jumped 84% in a week.

According to Banner Health Chief Clinical Officer, Dr. Marjorie Bessel hospitals have seen a 95% increase in Covid-19 patients since July 1 and 300% increase in ventilators and there is substantial spread in the vast majority of Arizona counties. Arizona is also second in the nation for pediatric deaths related to COVID-19, according to data published recently by the American Academy of Pediatrics.

Schools began welcoming back students to campus late last month and are already experiencing outbreaks across the state. Many are being forced back to online learning because they are not able to use simple mitigation tools like universal masking. The science around masking is settled. Masks work to prevent disease transmission. All recent public health agencies, both national and local, have issued statements recommending universal masks for K-12 students in schools. [1]

Arizonans have a right to safe schools for Arizona kids. Governor Ducey is attempting to prevent school officials from implementing any public health mitigation strategies in line with leading public health agencies, including the CDC and Arizona Department of Health Services (ADHS) to help protect students, all while COVID19 cases are again rising in our communities and more contagious variants are becoming more widespread.

The law passed by the state. banning schools from implementing such policies is likely unconstitutional, law doesn't take effect until Sept. 29 and poses a serious risk to life and health.

In short, follow the experts advice at he CDC. Implement mask mandates and while you are at it, bring back the options you offered last year to parents (virtual classes, cohorts, etc.)

Whereas emergency use products are specifically prohibited by federal law 21 U.S.C. §360bbb-3 from being mandated: "Authorization for medical products for use in emergencies ... require ...the option to accept or refuse administration of the product"; and

Whereas the CDC Advisory Committee on Immunization Practices (ACIP) affirmed in August 2020 that under an Emergency Use Authorization (EUA), experimental vaccines are not allowed to be mandatory; and

Whereas decades-old universally accepted Codes of Medical Ethics, including the Nuremberg Code and the Declaration of Helsinki unequivocally prohibit any form of coercion whatsoever for individuals to participate in a medical experiment; and

Whereas it is neither feasible nor safe to mandate experimental vaccination among minors given the low risk of children in transmitting community spread of COVID-19; and

Whereas public and private measures are nonetheless being considered to mandate experimental vaccinations in order to participate in certain public activities and functions of daily American life, including but not limited to: employment, in-person school attendance, public transportation, and concert performances; and

Whereas the medical evidence is clear and unambiguous that less than 1% of teachers and students have been infected in schools that have reopened; and

Whereas "vaccine passports," "digital health IDs," and other such required documentation pose substantial risks to personal privacy and equal treatment before the law for all citizens of the United States; and

Whereas administration of the experimental COVID-19 vaccines according to guidelines established by the CDC's Advisory Committee on Immunization Practices do not provide adequate protections for average Americans concerned about potential health hazards associated with the inoculations; and

Whereas the public, including dependent children, are entitled to receive unbiased, transparent, easily accessible medical information related to all vaccines from their public health officials; and

Whereas the doctors and nurses administering the inoculation are required by law to give informed consent and they cannot do they if they themselves are not informed; and

Whereas the emergency powers assumed by the chief executives of certain states as well as municipal leaders violate certain unalienable rights guaranteed under the US Constitution and its and Bill of Rights and therefore deserve redress; and

Whereas while these legitimate grievances are pursued by the courts of various states, lawmakers at the state and federal levels must enshrine certain rights against encroachment by decrees that are not medically or scientifically indicated, such as vaccine mandates, in order to ensure the continuity of these rights; and


Whereas specifically that a COVID-19 Vaccine Bill of Rights provided by this resolution against COVID-19 vaccine mandates provides an example of adoption for other legislative bodies across the United States to be recognized and upheld by the attorneys general of those states; and

Whereas that the major principles of this Vaccine Bill of Rights will include a minimum of five (5) of the following seven (7) provisions:

- No persons will be mandated, coerced, forced or pressured to take an experimental or "investigational" medication.
- All persons reserve the right, at all times, to determine what is in their own best medical interest without threat to their livelihood, schooling, or freedom of movement.
- No physician or nurse shall be asked by an employer to promote a COVID-19 vaccine.
- All healthcare providers must attest that they are aware of the VAERS database and their professional obligation to check it regularly and share information about VAERS with each vaccine recipient. All persons will be informed of the specific vaccine they are receiving.
- All persons must be given access to independent information to help them determine what is in their own best medical interest, including the risk of death based upon age/condition from contracting the virus naturally. This must include information from sources that are independent of a conflict of interest. For example, pharmaceutical companies have an inherent conflict of interest, as do government or quasi-government institutions. Such information can be included but cannot be the sole source of information.
- The frail elderly are additionally entitled to a knowledgeable, independent advocate with medical training to help them determine their own medical interest.
- Private businesses operating within the jurisdiction have no legal authority to require or mandate or coerce medication or experimental medication for any persons; and
- All public and private entities and persons must abide federal medical privacy laws(HIPPA) which protect patients' privacy

Whereas K-12 vaccinations cannot be required without certain clear and consistent exemptions applied, among them medical and conscience clauses, or risk forfeiting a district's or school board's authority to authorize such a mandate, nor can a vaccine mandate for these populations be a factor in federal and state school-aid funding; and

Whereas interstate carriers such as airlines and all forms of public transit calling for so-called "vaccine passports" as a condition of entry

## Nuremberg Code: Directives for Human Experimentation

ORI Introduction to RCR: Chapter 3. The Protection of Human Subjects

Table of Contents | Previous

- 1. The voluntary consent of the human subject is absolutely essential.
- 2. The experiment should be such as to yield fruitful results for the good of society.
- 3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease.
- 4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.
- 5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur.
- 6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.
- 7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.
- 8. The experiment should be conducted only by scientifically qualified persons.
- 9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end.
- 10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of thegood faith, superior skill and careful judgment required of him that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.
