To increase recruitment efforts, due to low enrollment caused by the pandemic. Funds from this grant will be used to rebuild the school website, approximately \$8,000.00. The remaining \$2,000.00 will be used to increase recruitment on and rebuild other social media pages.

There is no indirect cost for this grant. Funds are from a private organization that does not recognize indirect costs.

## ATTACHMENT A POTOFF PRIVATE PHILANTHROPY GRANT TERMS

# IMPORTANT: For the Potoff Private Philanthropy to release the grant funds awarded to you, please provide the following information, sign this Grant Agreement, and return to the Foundation at bill@potoffphilanthropy.org.

Grantee agrees that:

1. The Grantee shall expend grant funds exclusively for the stated charitable, religious, scientific, literary, or educational purposes described in the grant proposal.

2. The grant period will begin on the date posted on the check and will end one year from such date.

3. The Grantee has provided the Foundation with verification of the Grantee's public charity status under Sections 501(c)(3) and 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986, as amended (the "Code"), and agrees to notify the Foundation of any change in the Grantee's status.

4. Grantee warrants and represents that its receipt of this grant will not adversely affect Grantee's status as other than a private foundation within the meaning of Section 509(a) of the Code.

5. Should the Grantee's IRS tax status change, the Grantee agrees to notify the Foundation immediately and acknowledges that it may be required to return any unexpended funds to the Foundation.

6. The Grantee agrees to repay any part of the grant funds not used for the stated purpose of the grant. Any unexpended grant funds remaining at the expiration of the grant period shall be returned to the Foundation.

7. The Grantee shall not, under any circumstance, transfer, assign or encumber any portion of the grant. Furthermore, the Grantee agrees that the grant funds will not be expended, transferred, or used to carry on propaganda or otherwise attempt to influence legislation, to influence the outcome of any public election or to carry on any voter registration drive, or for any purpose that is prohibited by an applicable law of the United States or of any domestic or foreign jurisdiction, including without limitation, applicable laws proscribing the support of terrorism or terrorist organization.

8. The Grantee shall maintain accurate accounting records and retain records of receipts and disbursements related to the expenditure of grant funds and will keep such accounting records for at least two years after the end of the grant period. The Foundation may, at its expense and on reasonable notice to the Grantee, inspect, audit, or copy the Grantee's records pertaining to this grant.

9. The Grantee shall provide the Foundation with a final report thirty (30) days after the

completion of the project or program supported by the grant, or 30 days after the end of the grant period. Such report shall be in the form attached hereto. The Foundation may, at its discretion and on reasonable notice, request an interim report from the Grantee.

10. The Grantee may not acknowledge the Foundation's support of this project in any announcements and written materials. Please list any such acknowledgments as "Anonymous."
