**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The Perimeter Bicycling Association of America has requested the temporary closure of portions of Yucca Via between Old Ina Road and Ina Road for the annual El Tour De Tucson on Saturday, November 21, 2015 from 8:00 A.M. to 5:30 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions Yucca Via between Old Ina Road and Ina Road to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.


