Pursuant to Pima County Procurement Code 11.12.010, Competitive sealed bidding, on 7/6/2022, the Procurement Director approved an award of contract award of contract for an initial term of one (1) year and the shared annual award amount of \$127,000.00 with four (4) one-year renewal options.

On 1/10/2023, the Board of Supervisors approved Amendment No. 1, which increased the shared annual award amount by \$143,000.00 from \$127,000.00 to \$270,000.00 for a cumulative not-to-exceed contract amount of \$270,000.00.

This increase is required to fund new equipment purchases due to the increased number of recruits, and to ensure sufficient funding for using departments through the contract renewal date.
