**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

Pima Velo has requested the temporary closure of portions of Mc Cain Loop from 600 West Kinney Road to 2350 West Kinney Road for the Tucson Bicycle Classic on Friday, March 17, 2017 from 10:00 A.M. to 6:00 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Mc Cain Loop from 600 West Kinney Road to 2350 West Kinney Road to enhance the safety of the Tucson Bicycle Classic event by reducing potential vehicular conflicts.




