RE: BOS Agenda 12/5/23: Outside Agency Program Budget FY25

Please add this item to the Regular Agenda for 12/5/2023. Thank you.

Board of Supervisors:

Discussion/Direction/Action: Increasing the overall budget for the Outside Agency Program social services category grants (CWD grants) for FY25 from the current \$3.26M to \$3.86M, an increase of \$600,000. As we know, the pandemic exacerbated long-standing inequalities in American society, including here in Pima County. Those who experienced the greatest hardship in terms of housing, employment, food insecurity and more, were those who already were among the most vulnerable in our community. The needs, therefore, for additional support for our community members who are low-income, elderly, disabled, and the young, are greater than ever before. The Outside Agency Program is funded through the General Fund. All programs are administered by nonprofit partners across the county through a competitive RFP process.

Background:

The Outside Agency Program "targets economically disadvantaged and other at-risk populations, and specifically, it assures that support is provided to meet basic needs and services in rural areas." (OA website)

Nonprofit partners apply for the funds through a competitive RFP process that happens every other year. All applications are rigorously and thoughtfully reviewed by the **Outside Agency Citizen Review Committee**, consisting of one member each appointed by the Supervisors and one member appointed by the County Administrator. Funding for eligible social service providers happens in two-year funding cycles (Year 1 awarded based on the competitive RFP; renewal for Year 2 based on meeting benchmarks, and availability of funds). The RFP for FY25-FY26 is currently on the street and closes December 18th.

In FY24, the County's budget for the Outside Agency Program for social services was \$3.26M. This would increase the overall available budget to \$3.86M for FY25. The Outside Agency Citizen Review Committee will begin their review of the current applications in January, interview all applicants during March and April, make their final recommendations in May/June, and those recommendations for FY25 funding will come before the Board of Supervisors at our July 2, 2024, meeting. Historically, the Citizen Review Committee has often recommended funding levels that are below what the applicants requested, in order to be able to say yes to more applicants. Increasing the overall budget for the program will allow the Committee to recommend full funding for more eligible, deserving, and vitally important programs.

From the Citizen Review Committee's memo, re FY24 funding recommendations:

The agencies continue to provide important services to help meet Pima County needs, both rural and urban from Ajo, Arivaca, and Green Valley to Catalina. Listed below is a summary of the OA Category Funding Recommendations:
