Subject(s): Parcel Annexations of County Owned Property

The Northwest Fire District (NWFD) is formally requesting approval from the Pima County Board of Supervisors to annex specific county-owned parcels that are near and/or adjacent to its current territorial boundaries.

The District has recently conducted an annual audit of its boundaries and identified several county owned parcels, including adjacent roadways, that are not within any particular fire jurisdiction. NWFD is the closest response agency to these parcels, and therefore would likely be requested to be the primary responder to these county owned areas in the event of a fire or medical emergency.

Pima County and the NWFD are governmental agencies so there is no financial impact to either agency associated with the proposed annexation. However, the impact the District is seeking to have relates to improved accuracy and expediency for emergency response through annexation into the Northwest Fire District.

At present, the 911 fire/medical dispatch center does not have a defined response agency associated with these particular Pima County owned addresses. When an emergency occurs and the 911 system is activated, the dispatch center must manually search the computer aided dispatch (CAD) system to find the closest agency. Once the closest agency is identified, the dispatch center must then take additional time to contact and specifically request a response from the closest agency. These additional steps result in longer call processing times which create needless delays in emergency response, while still not guaranteeing an emergency response will be received from any particular agency.

As a result of annexing the proposed parcels into the Northwest Fire District, the 911 system will automatically dispatch NWFD as the responsible agency which expedites a guaranteed response from the closest emergency crews. This will provide for improved service delivery to the citizens of Pima County while facilitating some "clean up" of the Northwest Fire Districts borders.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS AND OF THE BOARD OF DIRECTORS OF THE PIMA COUNTY REGIONAL FLOOD CONTROL DISTRICT REQUESTING THE ANNEXATION OF CERTAIN COUNTY-OWNED AND FLOOD CONTROL DISTRICT-OWNED PROPERTIES INTO THE NORTHWEST FIRE DISTRICT PURSUANT TO A.R.S. § 48-262(I)

The Board of Supervisors of Pima County and the Board of Directors of the Pima County Regional Flood Control District find:

- 1. A.R.S. § 48-262(I) provides that any person, including a county, within a county with a fire district, that has land contiguous to the boundaries of the fire district may request, in writing, that the governing body of the fire district amend the fire district boundaries to include the person's land.
- 2. Pima County ("County") owns several parcels of land ("the County Parcels") contiguous with, but not included in, the existing boundaries of the Northwest Fire District ("NWFD").
- 3. The Pima County Regional Flood Control District ("District") owns several parcels of land ("the District Parcels") contiguous with, but not included in, the existing boundaries of the NWFD.
- 4. The Pima County Office of Emergency Management has reviewed the potential impact of annexation of the parcels set forth in Exhibit A of this Resolution ("the County parcels") and finds that the annexation will be beneficial to the County and the District.
- 5. As required under A.R.S. § 48-262(C), neither the County Parcels nor the District Parcels surround an area of unincorporated territory that is not also included in the NWFD.
- 6. Annexation of the County Parcels and the District Parcels into the NWFD:
 - a. Will not fiscally impact the County or the District;
 - b. Will improve the accuracy and expediency of emergency response by NWFD; and
 - c. Will improve emergency service delivery to the citizens of Pima County served by NWFD.
- 7. As set forth in A.R.S. § 48-262(I), petitions and impact statements regarding this request for annexation of the County Parcels and the District Parcels is not required in order to amend the NWFD boundaries.

NOW, THEREFORE, BE IT RESOLVED, that the Pima County Board of Supervisors and the Board of Directors of the Pima County Regional Flood Control District:

- A. Request the governing body of the Northwest Fire District ("the NWFD Board") to annex into the fire district all the County Parcels and the District Parcels set forth in Exhibits A and B of this Resolution;
- B. Request the NWFD Board determine whether the inclusion of the County Parcels and the District Parcels will be beneficial to NWFD, Pima County, and the Pima County Regional Flood Control District; and, if found to be beneficial:
 - 1. Order the NWFD boundaries be amended to include the County Parcels and the District Parcels of the NWFD; and
 - 2. Cause to be recorded in the Office of the Pima County Recorder that order, including the legal description of the County Parcels and the District Parcels set forth in Exhibit B of this Resolution, to effectuate the annexation.
