**AMENDMENT NO. ONE  
TO THE INTERGOVERNMENTAL AGREEMENT  
Between Pima County and the City of Tucson**

**1.0 BACKGROUND AND PURPOSE**

- 1.1 On March 17, 2020, County and City of Tucson entered into the above-referenced Intergovernmental Agreement (“Agreement”) with a retroactive term commencing on October 1, 2019. The Agreement is a Subaward of funds from the FY19 National Sexual Assault Kit Initiative (“SAKI”) grant.
- 1.2 County is acting as the fiscal agent for the City under the SAKI grant and is increasing the funding to the City from the grant.

**2.0 COMPENSATION AND PAYMENT**

- 2.1 County is increasing the Maximum Allocated Amount by \$7,500.00 from federal grant funds from OJP.

All other provisions of the Agreement not specifically changed by this Amendment remain in effect and are binding upon the parties.
