The subrecipient has provided additional capacity to distribute assistance as part of the Emergency Rental Assistance Program (ERAP) 1 and 2 since October 2021. This amendment will extend the termination date three months, through December 31, 2023, and add additional funding to allow services to continue as Pima County exhausts funding. Subrecipient will continue to provide housing stability services including housing counseling, fair housing counseling, case management related to housing stability, housing related services for survivors of domestic abuse or human trafficking, attorney's fees related to eviction proceedings, and specialized services for individuals with disabilities or seniors that supports

Yes. Additional Emergency Rental Assistance Program funds from the U.S. Department of Treasury were approved at the July 25, 2023 Pima County Board of Supervisors' Meeting (BOS). The amendment could not be processed until after the BOS approved the additional funds. Subrecipient provided County a revised budget on August 9, 2023, and revisions to that budget were completed August 29, 2023. The first available Board of Supervisors meeting is October 3, 2023. The negative impact of this amendment not being approved is Pima County residents may not receive housing stability services.

SUBAWARD AMENDMENT

1. BACKGROUND AND PURPOSE.

- 1.1. Background. On December 21, 2021, County and Subrecipient (collectively "Parties") entered into the above referenced agreement ("Agreement") to provide eligible households with rent and utility assistance and housing stability services.
- 1.2. <u>Purpose</u>. County requires additional services for housing stability services.
- 2. TERM. The County is exercising a portion of the second extension option to renew the contract for an additional three months commencing on 10/01/2023 and terminating on 12/31/2023. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.

3. COMPENSATION AND PAYMENT.

3.1. Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in Section 5.1 of the original agreement, is increased by \$74,456.00. County's total payments to Subrecipient under this contract, including any sales taxes, will not exceed \$610,033.60.
