THIRD AMENDMENT TO INTERGOVERNMENTAL AGREEMENT BETWEEN PIMA COUNTY, ARIZONA AND TOWN OF SAHUARITA

CONTRACT No. CTN-IT-1200000000000000000292 (Former contract No. 01-14-S-138128-0606)

THIS AMENDMENT to the Intergovernmental Agreement ("IGA") between Pima County and the Town of Sahuarita is entered into by and between Pima County ("County"), a political subdivision of the State of Arizona, and the Town of Sahuarita (Sahuarita), a municipal corporation of the State of Arizona, for the purpose of providing radio communications service and equipment maintenance to Sahuarita.

RECITALS

County and Sahuarita entered into an IGA effective June 20, 2006, with expiration date of November 30, 2011, which has previously been amended to extend through November 30, 2013. With this Third Amendment, the parties desire to amend the IGA to extend the Agreement effective December 1, 2013 through November 30, 2014.

AGREEMENT

WHEREFORE, the parties agree as follows:

- 1. The term of the IGA is hereby extended effective December 1, 2013 through November 30, 2014.
- 2. All other provisions of the IGA shall remain in effect and continue to be binding upon the parties.
