#### CONTRACT AMENDMENT

WHEREAS, the Regional Transportation Authority of Pima County (RTA) on December 9, 2010 entered into an Intergovernmental Agreement (IGA) with Pima County (County) to cooperate in the provision of regional transit services including urban area service (Sun Tran and Sun Express), mandated Americans with Disabilities Act complementary paratransit service (Sun Van), and rural transit (Sun Shuttle) in unincorporated County.

WHEREAS, County and RTA wish to extend the IGA for fiscal year 2024/2025.

NOW, THEREFORE, the Agreement is amended as follows:

- 1. **Term.** The parties agree to extend the term for one additional year commencing on July 1, 2024 and terminating on June 30, 2025. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.
- 2. Amended Exhibit A. The parties agree to incorporate Amended Exhibit A to the IGA.
- 3. **Maximum Payment Amount.** The maximum payment amount the County will spend under this contract is increased by \$7.631.479.00. County's total payments will not exceed \$80,107.874.56.

All other provisions not specifically changed by this Amendment shall remain in full force and effect.

In Witness Whereof, the Regional Transportation Authority of Pima County has caused this Amendment to be executed by its Chair of the Board and attested by the Executive Director, and Pima County has caused this Amendment to the Agreement to be executed by the Chair of the

Pima County Board of Supervisors, upon resolution of the Board and attested to by the Clerk of the Board.
