*Project Title/Description:

Consulting Services for Planning, Technical/Training Assistance & Report Planning This contract can be found in OnBase by searching Contracts 19*427 in Doc_ID_AMS.

*Purpose:

Consultant services to assist Pima County and City of Tucson, via its US Department of Housing and Urban Development (HUD) Consortium, in providing planning, technical/training assistance and report preparation to complete its required 2020-2025 HUD Consolidated Plan ("Con Plan"), respective 2020-2021 Annual Action Plans ("AAP"), Citizen Participation Plan ("CPP") and updated Analysis of Impediments to Fair Housing ("AI").

This is an extension of one (1) year to complete the services outlined in the scope of work. Additional services are added to the scope of work in this extension as well as additional funding from HUD Community Development Block Grant ("CDBG") and HOME Investment Partnership Program ("HOME"). The City of Tucson will be responsible for half (50%) of additional funds being added to this contract under CTN-CD-19-427.1.

*Program Goals/Predicted Outcomes:

Goal: Consultant services will provide technical assistance on CARES Act implementation to assist Pima County and the City of Tucson in the prioritization of respective HUD entitlement funding sources.

Predicted outcome: HUD plans will be completed for both the City of Tucson and Pima County securing HUD entitlement funding and attracting other leveraged resources for the benefit of county residents.

*Public Benefit:

An estimated \$54 million in HUD entitlement resources will be made available for projects addressing housing, community development, homelessness, and special populations in Pima County and the City of Tucson.

*Metrics Available to Measure Performance:

Upon request, provide technical assistance and training to City and County staff and assist with CARES Act Implementation. Underwrite proposed HOME projects as needed.

*Retroactive:

Yes, to March 30, 2020. Finalizing documentation and reconfirming metrics delayed contract process. If not approved, HUD funding may not be allocated.

AMENDMENT NO. ONE (1)

1.0 BACKGROUND AND PURPOSE.

1.1. <u>Background</u>. County appropriated \$150,000.00 of FY 2018-2019 and FY 2019-2020 Community Development Block Grant ("CDBG") funds for Kuehl Enterprises, LLC. ("Contractor") to provide planning, technical/training assistance, and underwriting report preparation for City and County HUD Community Planning and Development entitlement grant funding for HUD program years 2020-2025.

1.2. Purpose.

- 1.2.1. The Consolidated Plan Presentation, Report, and Annual Action Plan activities are an 18-month process.
- 1.2.2. HUD has made "Coronavirus Aid, Relief, and Economic Security Act" or the "CARES Act" resources available in order to ensure that various CDBG, HOME, Emergency Service Grant ("ESG") and Housing Opportunities for Persons with Aids ("HOPWA") plans and policies which were being or had been completed are updated to include the changes that have

- occurred since the emergency declarations instituted because of the COVID-19 pandemic.
- 1.2.3. In order to ensure that the Reports and Plans set forth in the Scope of Work, Exhibit A, paragraph 1.2 are revised to account for current, and future, circumstances related to the health emergency, the Board of Supervisors finds it is in the best interests of the residents of Pima County to extend the Agreement for an additional one (1) year.
- 2.0 TERM AND EXTENSIONS, SECTION 1.0. Pursuant to paragraph 1.2, County exercises a portion of the allowed Extension Options. This Contract will terminate on March 31, 2021.
- 3.0 COMPENSATION AND PAYMENT, SECTION 3.0. is amended as follows:
- 3.1. The Maximum Allocated Amount is increased to \$200,000.00.
- 3.2. The table is deleted in its entirety and replaced with the following:

3.3. Paragraph 3.15.1 is deleted and replaced with the following:

Pursuant to 2 CFR §2400.101, unless excepted under 24 CFR chapters I through IX, the cost principles set forth in 2 CFR part 200, Subpart E, as may be modified by amendments and additions, will be used to determine whether an incurred cost will be reimbursed under this Agreement.

4.0 SECTION 33.0 – ISRAEL BOYCOTT CERTIFICATION is added:

Pursuant to A.R.S. § 35-393.01, if Contractor engages in for-profit activity and has 10 or more employees, and if this Agreement has a value of \$100,000.00 or more, Contractor certifies it is not currently engaged in, and agrees for the duration of this Agreement to not engage in, a boycott of goods or services from Israel. This certification does not apply to a boycott prohibited by 50 U.S.C. § 4842 or a regulation issued pursuant to 50 U.S.C. § 4842.

- **5.0 EXHIBIT A**, is amended as follows:
- 5.1. **Paragraph 1.3** is deleted and replaced with the following:

Contractor will complete other projects related to CPD, as requested, including but not limited to grant writing, application preparation, project underwriting and risk analysis.

- 5.2. Section 7 -- <u>Deliverables, Timeline and Budget</u> is deleted and replaced with the following Section 7, Additional Analysis and Report.
 - 7. **Analyses and Reports.** Contractor will:
 - 7.1. Upon request, provide technical assistance and training to City and County Staff and local non-profit housing agencies involved in CPD programs.
 - 7.2. Write grants and prepare applications of County and City.
 - 7.3. Underwrite proposed HOME projects. Underwriting will include, but is not limited to:
 - 7.3.1. Review and analyze sources and uses of funds and determine if costs are reasonable;
 - 7.3.2. Assess market demand and market risks for the area in which the proposed HOME project is located;

- 7.3.3. Review and assess applicant's experience and financial capacity to successfully complete the proposed HOME project (Developer Risk);
- 7.3.4. Analyze the long-term financial feasibility of the proposed HOME project based on pertinent available data and written commitments from additional funding sources;
- 7.3.5. Analyze the proposed HOME project operating pro forma; and
- 7.3.6. In conformance with federal and state standards, conduct a subsidy layering analysis to assure that federal, state and local funding sources to not result in over-subsidization of the proposed HOME project.
- 7.4. Provide County or City, as appropriate, with a detailed report of each proposed HOME project underwritten.

5.3. **Section 8 – CARES Act Implementation** is added to read:

- 8. <u>CARES Act Implementation</u>. In order to update the reports and plans set forth in paragraph 1.2 above, and to comply with guidance for the use of CARES Act funding, as it is released by the federal government, Contractor will:
 - 8.1. Upon request, provide technical assistance and training to City and County staff and local non-profit housing agencies involved in HUD CARES Act planning, coordination and implementation.
 - 8.2. Assist Consortium in implementing expedited public notice and processes required to amend existing or proposed HUD plans to incorporate HUD CARES Act resources.
 - 8.3. Help Consortium revise and update the plans prepared pursuant to this Agreement and accurately program CPD CARES Act projects and activities consistent with Con Plan goals, objectives, and performance measurements in IDIS, as amended, modified or waived by HUD.
 - 8.4. Meet with County and City to review updated drafts of plans as required by HUD
 - 8.5. Prepare executive summaries of CPD Cares Act amendments, modification or waivers for the governing bodies of City and County.
 - 8.6. After approval and direction from the governing bodies, prepare submittals and work with County and City to upload the respective CARES Act projects to IDIS.
 - 8.7. Prepare HUD required checklists for County and City as needed to ensure compliance with CARES Act.
