Purpose: On November 10, 2015, Pima County entered into an agreement with the City of Tucson to provide for the City's contribution of funding for the construction of roadway improvements to Sunset Road between Silverbell and I-10. Phase I has been completed. On June 21, 2022, the agreement was amended to address funding and construction of Phase 2 of the project which will build the connection from River Road to I-10. This project is managed by Arizona Department of Transportation (ADOT).

Phase 2 of the project has not been completed, and this amendment is to extend the termination date.

CONTRACT AMENDMENT

1. Background and Purpose.

1.1. Background. On November 10, 2015, Pima County ("**County**") and the City of Tucson ("**City**") entered into an Intergovernmental Agreement ("**Agreement**"), CTN-TR-16-047, to provide for City's contribution of funding for the construction of roadway improvements to Sunset Road between Silverbell and I-10, **Phase 1** of the project identified as Roadway Improvement Element #8 in the Regional Transportation Authority's Regional Transportation Plan (the "**Project**"). Phase 1 has been completed.

On June 21, 2022, the Parties amended the agreement to address funding and construction of **Phase 2** of the Project, improvements to Sunset Road between I-10 and River Road. The Parties authorized the Arizona Department of Transportation ("ADOT") to manage construction of Phase 2.

1.2. Purpose. **Phase 2** of the Project has not been completed, and more time is required for project completion. The Parties now wish to amend the Agreement to extend the termination date.

2. Term. The Parties agree to extend the term for five additional years commencing on November 11, 2025 and terminating on November 10, 2030.

All other provisions of the Agreement not specifically changed by this Amendment remain in effect and are binding upon the Parties.
