I also give thanks to the previous work the Board of Supervisors has done on this issue and their careful consideration leading to their negative vote on the matter in 2007.

Tim Steller's article in the Arizona Daily Star on 7/25/2021 cited the negative impact on important local natural areas including the Arizona-Sonora Desert Museum and Saguaro National Park West. Additionally, the Department of the Interior stated with respect to the Tucson Mitigation Corridor, "The corridor supports multiple biological processes that are critical to the ecological health of Saguaro National Park and Tucson Mountain Park." They also stated that putting I-11 through that area would negate the benefits of the Corridor. The proposal was also opposed by these agencies:

The Arizona Game and Fish Department, National Park Service, Coronado National Forest, Bureau of Reclamation and other agencies weighed in with similar blasts about the effects of the proposed freeway on the mitigation corridor or Saguaro National Park, among other properties.
