Title: Temporary Road Closure Resolution

Introduction/Background:

Tucson Marathon Events, LLC has requested the temporary closure to portions of Golder Ranch Drive, Twin Lakes Drive, Hawser Street, Coronado Forest Drive and Bowman Road for the Tucson Marathon on Saturday, December 7, 2019 from 4:30 A.M. to 3:00 P.M.

Discussion:

As a result of the Pima County Transportation traffic control plan review, road closures are recommended to help facilitate the event.

Conclusion:

Pima County Transportation recommends the temporary closure to portions of Golder Ranch Drive, Twin Lakes Drive, Hawser Street, Coronado Forest Drive and Bowman Road within the extent of the event to enhance the safety of the Tucson Marathon event by reducing potential vehicular conflicts.

Recommendation:

Pima County Transportation recommends approval of this resolution to temporarily close portions of Golder Ranch Drive from Oracle Road to Coronado Forest Drive, Twin Lakes Drive from Golder Ranch Drive to Hawser Street, Hawser Street from Twin Lakes Drive to Coronado Forest Drive, Coronado Forest Drive from Hawser Street to Golder Ranch Drive and Bowman Road from Golder Ranch Drive to White Hill Way within the extent of the event for the Tucson Marathon on Saturday, December 7, 2019 from 4:30 A.M. to 3:00 P.M.

3. The Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure to portions of Golder Ranch Drive, Twin Lakes Drive, Hawser Street, Coronado Forest Drive and Bowman Road to support this event.

Portions of Golder Ranch Drive from Oracle Road to Coronado Forest Drive, Twin Lakes Drive from Golder Ranch Drive to Hawser Street, Hawser Street from Twin Lakes Drive to Coronado Forest Drive, Coronado Forest Drive from Hawser Street to Golder Ranch Drive and Bowman Road from Golder Ranch Drive to White Hill Way within the extent of the Tucson Marathon will be temporarily closed to public traffic on Saturday, December 7, 2019 from 4:30 A.M. to 3:00 P.M.
