RE: Kinder Morgan Sierrita Pipeline Project Mitigation Agreement

Dear Chair Bronson and Supervisors:

The Coalition for Sonoran Desert Protection, representing 41 conservation and community groups, does not support the Mitigation Agreement and Agreement for Easements between Pima County, the Pima County Regional Flood Control District, and Sierrita Gas Pipeline, L.L.C. that you will be considering at your June 17, 2014 meeting. We believe that portions of these agreements are inadequate and cannot support the Mitigation Agreement as it is currently written.

Pima County's Sonoran Desert Conservation Plan (SDCP) is a ground-breaking effort to conserve the most ecologically valuable lands and resources in Pima County. The SDCP addresses several elements of resource conservation, including cultural preservation, open space conservation, protection of mountain parks and natural reserves, ranch conservation, and ecological conservation. One key component of the SDCP is the Maeveen Marie Behan Conservation Lands System (CLS).

The Sierrita Pipeline Project will impact 860 acres of CLS lands, including Important Riparian Areas, Biological Core Management Areas, Multiple Use Management Areas, and Special Species Management Areas. Pima County guidelines recommend various landscape conservation objectives for each of these CLS categories, along with specific mitigation measures and mitigation ratios for impacts to CLS lands. The project will also impact over 200 jurisdictional washes with significant loss of riparian habitat, which will be mitigated via an in-lieu fee of \$3 million from Kinder Morgan.

The Mitigation Agreement that you are considering on June 17th proposes that the County accept \$1 million from Kinder Morgan "to purchase lands that could be used to offset permanent habitat losses." CLS guidelines and mitigation ratios recommend that 3,290 acres of mitigation lands be purchased to offset the impacts to 860 acres of CLS lands (see table below). Current land values in the Altar Valley are approximately \$1,500/acre. Thus, Kinder Morgan should be giving the County \$4,935,000 to fully mitigate for impacts to CLS lands. The \$1 million in mitigation monies proposed in the Mitigation Agreement is wholly inadequate, providing

funding to purchase simply 667 acres of CLS lands in the Altar Valley, less than 1:1 mitigation. This amount should be increased to \$4,935,000 to fully compensate the County for the substantial impacts to CLS lands.


Acres of Impact and Mitigation Acres for Kinder Morgan Sierrita Pipeline Project

We also understand that Kinder Morgan has agreed to extend its 5-year Monitoring Plan to 20 years. We appreciate the County's work and analysis in this area and your commitment to ensuring that the pipeline area is monitored for a sufficient length of time. However, we have serious concerns that restoration, or even effective mitigation of impacts, will occur within any timeframe. And while monitoring targets and performance criteria are outlined and reports will be provided, there is no enforcement included should the actions taken not result in acceptable restoration. We encourage the County to include accountability and enforcement measures in the Agreement.

The Coalition thanks the County for working toward an improved Long Term Monitoring Plan as outlined in Exhibit C of the Mitigation Agreement and summarized in the County Administrator's June 17, 2014 memo. We remain, however, disappointed with the Federal Energy Regulatory Commission, and even more so with the Kinder Morgan company.
