Addendum 1 Item #1 Request by Attorney Sam Brown for Executive Session re: public meetings & action

There is only **one** reason to have an Executive Session to discuss the issue of excluding the public from a Public meeting of the Board of Supervisors. That one reason is because of Chair, Adelita Grijalva and her desire to hide behind the shield of an Executive Session because she cannot face the public for her actions. Both legal opinions of (1) undated memo from Attorney Sam Brown outlining his reasons why Chair Grijalva could take the action excluding a citizen and (2) legal opinion of Munger, Chadwick & Denker, PLC expressing numerous violations by Chair Grijalva based on Arizona Statutes and the US Constitution. Both opinions are available on-line at the Board of Supervisors website. There is no breach of privacy for Shirley Requard, her name is also in the public as the citizen banned from the BOS meetings. Also in the public eye are the videos of all the meetings. Pima County residents deserve to see and hear how this issue and others are discussed and resolved. An Executive Session only provides Chair Grijalva a method to continue with lack of transparency to Pima County. Do not allow an Executive Session for these items at the 4-4-23 BOS meeting.

Agenda Items #28, #29, #30, #31, #45 Total = \$11,389,569.87 funding illegals food, shelter + other

Dear Administrator Leshar and Board:

Pima County needs a solution to solve the potential collapse of public infrastructure and services now before Pima County continues to maintain Tucson as a sanctuary city by feeding, housing, transporting, and providing medical assistance to "asylum seekers." Immigration is not a political issue; it is an American issue that has devastating impacts on communities, farms, hospitals, and residents when it is mismanaged.

Jan Leshar states, "Border Patrol estimates that Pima County's humanitarian partners may receive up to **1200-1500 people ("asylum seekers") per day**. These numbers will overwhelm existing local capacity without significant federal support. The end of Title 42 will significantly impact current operations for Pima County border response, including Emergency Management, Procurement, Grants Management and Innovation, Community & Workforce Development, Libraries, Fleet Services, Health, and others". Also see Grant Management and Innovations Agenda Items Nos. 28, 29, 30, 31, and 45 showing the following Federal Department of Homeland Security grant funding awards budgeted to start 4/1/2023 and end 9/30/2023 for "asylum seekers":

- Agenda Item 28. \$2,891,391.00 for Catholic Community Services of Southern Arizona, Inc., to provide for Fiscal Agent Pima County / Emergency food and shelter.
- Agenda Item 29. \$823,000.00 for the City of Tucson, to provide Fiscal Agent Pima County / Emergency food and shelter to families and individuals.
- Agenda Item 30. \$135,148.00 for The Inn of Southern, Arizona Inc., to provide Fiscal Agent Pima County / Emergency food and shelter to families and individuals.
- Agenda Item 31. \$750,000.00 for SJM Premier Medical Group, L.L.C., Amendment No. 6, to provide COVID-19 medical support for refugee populations.
- Agenda Item 45. Acceptance of \$3,395,015.87 to provide food, shelter, and other humanitarian support to "asylum seekers" at Casa Alitas Welcome Center, Comfort Suites, and Red Roof Inn.

Since there is not a dollar amount assigned per "asylum seeker," it is difficult to determine how quickly Pima County will use up the federal funding, but it is evident they will continue to maintain Tucson as a *de facto sanctuary city* with or without federal funding, and without mentioning any solutions to solve the collapse of public infrastructure and services that will likely occur due to the

significant influx of “asylum seekers” mentioned in Jan Leshner’s memorandum. This is alarming.

Agenda Item 28. **\$2,891,391.00** for Catholic Community Services of Southern Arizona, Inc., to provide for Fiscal Agent Pima County/Emergency food and shelter.

Agenda Item 29. **\$823,000.00** for the City of Tucson, to provide Fiscal Agent Pima County / Emergency food and shelter to families and individuals.

Agenda Item 30. **\$135,148.00** for The Inn of Southern, Arizona Inc., to provide Fiscal Agent Pima County / Emergency food and shelter to families and individuals.

Agenda Item 31. **\$750,000.00** for SJM Premier Medical Group, L.L.C., Amendment No. 6, to provide COVID-19 medical support for refugee populations.

Agenda Item 45. **\$3,395,015.87** for food, shelter, and other humanitarian support to "asylum seekers" at Casa Alitas Welcome Center, Comfort Suites, and Red Roof Inn.
