Title: Sycamore Leaf Road No U-Turn

Introduction/Background:

The reason for this ordinance is to establish no u-turns on Sycamore Leaf Road for westbound traffic at the median bullnose 400 feet east of Canyon Edge Trail.

Discussion:

Pima County Traffic Engineering staff conducted field observations for Copper Ridge Elementary School located at Sycamore Leaf Road and Canyon Edge Trail. These observations determined that westbound vehicles making u-turns at the median bullnose were causing a conflict with school aged pedestrians using the school crosswalk and other vehicular traffic.

Conclusion:

Prohibiting u-turns will allow for improved safety at the location by minimizing conflicting vehicular and pedestrian movements.

Recommendation:

Pima County Traffic Engineering recommends that u-turns be prohibited on Sycamore Leaf Road for westbound traffic at the median bullnose 400 feet east of Canyon Edge Trail.

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING THE TURNING OF VEHICLES ON SYCAMORE LEAF ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-751, as amended, to regulate or prohibit the turning of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is necessary for the protection and convenience of the traveling public to prohibit u-turns for westbound vehicles on Sycamore Leaf Road at the median bullnose approximately 400 feet east of Canyon Edge Trail,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

- **SECTION 1.** Westbound traffic is hereby prohibited from making u-turns on Sycamore Leaf Road at the median bullnose approximately 400 feet east of Canyon Edge Trail.
- **SECTION 2.** All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.
- **SECTION 3.** This ordinance shall take effect when and to the extent that signs are posted to provide notice to the public of the prohibition.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law. **SECTION 5.** The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
