Pima County Department of Transportation has requested an abandonment of Sunset Road from the Freeway Frontage Road to Silverbell lying within Sections 7, 8, 17 & 18, Township 13, Range 13 G&SRM, Pima County, Arizona.	
Discussion:	
The subject roadway was established by Road Proceeding Number 243A recorded in Book 3 of Maps at Page 39. This roadway was completed as part of the bridge improvements over the Santa Cruz River, which was subsequently destroyed by flooding in 1983. New bridge improvements over the Santa Cruz ar currently under construction south of Sunset Road and will be established as new right-of-way under a roa proceeding later this year.	e d
Conclusion:	
This abandonment request has been reviewed and approved by appropriate County staff and applicable utility companies and no properties will be left without public or private legal access. Pima County has determined that the subject roadway is not needed for public use and shall be vacated at no cost upon conveyance to Pima County Floo Control District pursuant to A.R.S. 28-7215(B).	d

The Board of Supervisors of Pima County, Arizona finds:

- 1. A request has been made by Pima County Department of Transportation for the vacation of all of that portion of Sunset Road, as established in Road Proceeding Number 243A recorded in Book 3 of maps at page 39, said portion being more particularly described and depicted in attached **Exhibit A.**
- 2. The County has determined, pursuant to Arizona Revised Statutes (A.R.S) § 28-7215(B), that the subject public roadway was created by Road Proceeding Number 243A and is not needed for public use as it will be replaced by a new road proceeding establishment to be located south of existing Sunset Road, and that no land adjoining said roadway would be left without public or private legal access pursuant to A.R.S. § 28-7202.

NOW THEREFORE, BE IT RESOLVED,

- <u>Section 1.</u> The portion of Sunset Road described and depicted on <u>Exhibit A</u> shall be disposed of by conveyance to Pima County Flood Control District, ("Grantee") pursuant to A.R.S. § 28-7205.
- <u>Section 2.</u> The Chair of the Board of Supervisors is hereby authorized to execute a quit claim deed to the Grantee for said conveyance of the portion of the subject roadway as described and depicted on $\underline{Exhibit\ A}$.
- <u>Section 3.</u> The quit claim deed shall be promptly recorded and upon recordation of the quit claim deed, the described portion of the subject roadway shall be deemed to be vacated and title shall vest in the Grantee.




