Amendment of Award: Master Agreement No. MA-P0-16-101, Amendment No. 11. This Amendment extends the termination date to 01/31/2024. No additional funds required at this time. Administering Department: Information Technology.

\*Procurement Method:

Pursuant to Pima County Procurement Code 11.24.010, Cooperative procurement authorized, on October 06, 2015, the Board of Supervisors approved an award of contract for an initial term of one (1) year and an annual award amount of \$500,000.00 with four (4) one-year renewal options.

On 9/12/2016, the Procurement Director approved Amendment No. 01, which extended the termination date to 10/05/2017 and added a partial annual award amount of \$254,000.00 for a cumulative not-to-exceed contract amount of \$754,000.00.

On 6/22/2017, the Procurement Director approved Amendment No. 02, which extended the termination date to 10/05/18 and added the annual award amount of \$500,000.00 for a cumulative not-to-exceed contract amount of \$1,254,000.00.

On 9/4/2018, the Board of Supervisors approved Amendment No. 03, which extended the termination date to 10/05/19, increased the annual award amount by \$2,500,000.00 from \$500,000.00 to \$3,000,000.00 and also included a onetime increase of \$2,000,000.00 for a cumulative not-to-exceed contract amount of \$6,254,000.00.

On 5/21/2019, the Board of Supervisors approved Amendment No. 04, which increased the contract not-to-exceed amount by \$5,400,000.00 for a cumulative not-to-exceed contract amount of \$11,654,000.00. Effective 10/06/19, the annual award amount was increased by \$1,200,000.00 from \$3,000,000.00 to \$4,200,000.00.

On 6/12/2019, the Procurement Director approved Amendment No. 05, which extended the termination date to 10/05/2020 and added the annual award amount of \$4,200,000.00 for a cumulative not-to-exceed contract amount of \$15,854,000.00.

On 8/17/2020, the Board of Supervisors approved Amendment No. 06, which extended the termination date to 07/31/2021 and increased the contract amount by \$6,620,000.00 for a cumulative not-to-exceed contract amount of \$22,474,000.00.

On 7/6/2021, the Board of Supervisors approved Amendment No. 07, which extended the termination date to 07/31/2022 and added the annual award amount of \$4,200,000.00 for a cumulative not-to-exceed contract amount of \$26,674,000.00.

On 7/5/2022, the Board of Supervisors approved Amendment No. 08, which extended the termination date to 02/28/2023 and increased the not-to-exceed amount by \$10,500,000.00 for a cumulative not-to-exceed contract amount of \$37,174,000.00.

On 02/21/2023 the Board of Supervisors approved Amendment No. 09, which extended the termination date to 07/31/23. No additional funding was added and the contract not-to-exceed amount remained at \$37,174,000.00.

On 07/25/2023 the Board of Supervisors approved Amendment No. 10, which extended the termination date to 10/31/23. No additional funding was added and the contract not-to-exceed amount remained at \$37,174,000.00.

This extension is needed for the continuation of goods and services and to coincide with the State of Arizona contract ADSP016-098839 which has been extended through 01/31/2024.
