Introduction/Background:

The Vail Preservation Society has requested the temporary closure of portions of Colossal Cave Road from Via Rancho del Lago to Great Horned Owl Way for the A Colossal Fourth event on Tuesday, July 4, 2017 from 9:00 A.M. to 11:00 A.M.

Discussion:

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of Colossal Cave Road from Via Rancho del Lago to Great Horned Owl Way to enhance the safety of the Vail July 4th Parade event by reducing potential vehicular conflicts.

Staff recommends approval of this resolution to temporarily close portions of Colossal Cave Road on Tuesday, July 4, 2017 from 9:00 A.M. to 11:00 A.M.
