FOURTH AMENDMENT TO INTERGOVERNMENTAL AGREEMENT

This Fourth Amendment ("Fourth Amendment") to the Intergovernmental Agreement ("Agreement") is entered into as of the date of final signature to this Fourth Amendment ("Effective Date") by and between Pima County Community College District ("College") and Pima County ("County") on behalf of Pima County Sheriff's Department ("Department"). College, County, and Department may be referred to collectively as Parties ("Parties") in this Fourth Amendment.

RECITALS

WHEREAS, the Parties entered into the Agreement on August 23, 2019 ("Agreement Effective Date"), for delivery of Adult Basic education services ("Educational Services") by College to Department at Department's Pima County Adult Detention Complex.

WHERAS, the Parties entered into the First Amendment ("First Amendment") to the Agreement on July 24, 2020 ("First Amendment Effective Date") to extend the term of the Agreement up through and to June 30, 2021.

WHEREAS, The Parties entered into the Second Amendment ("Second Amendment") on June 22, 2021 ("Second Amendment Effective Date") to extend the term of the Agreement up to and through June 30, 2022.

WHEREAS, the Parties entered into the Third Amendment ("Third Amendment") on September 22, 2022 ("Third Amendment Effective Date").


WHEREAS, the Parties desire to further amend the Agreement as set forth below.

NOW, THEREFORE, in consideration of mutual promises contained herein, the Parties hereby agree as follows:

- 1. **EXTENDED TERM.** The term of the Agreement is hereby renewed and extended up to and through June 30, 2024.
- 2. **PAYMENT TERMS**. County shall make payment to College for the Educational Services provided during the renewed term as follows:

3. **FULL FORCE AND EFFECT.** Except as stated in this Fourth Amendment, all other terms and conditions of the Agreement, including in all attachments, remain in full force and effect. All capitalized terms not otherwise defined in this Third Amendment shall have the meaning ascribed to them in the Agreement.
