Title: Seeking permission to advertise Establishment of Sunset Road and Silverbell Road under Road Proceeding No. 3022 on December 2 and 9, 2016 in the Daily Territorial.

Introduction/Background:

Seeking permission by the BOS to advertise Road Proceeding No. 3022 - Sunset Road and Silverbell Road on December 2 and 9, 2016. The Sunset Road, Silverbell Road to I-10 Road Improvement Project has changed the alignment of Sunset Road and Silverbell Road.

Discussion:

The purpose of Road Proceeding No. 3022 is to establish the new alignment of Sunset Road and Silverbell Road. The Department is "Seeking Permission" from the BOS to advertise this Road Establishment as is required by A.R.S. 28-6703. If permission to advertise is approved, the final hearing date for this Road Establishment is scheduled for December 13, 2016.

Conclusion:

If Approved: Department will proceed to advertise the Establishment under Road Proceeding No. 3022 on December 2 and 9, 2016 in the Daily Territorial and would meet the requirements as defined in A.R.S. 28-6703.

If Denied: The Department will not advertise Road Proceeding No. 3022 and will not purse the establishment of the new alignment of Sunset Road, Silverbell Road to I-10 Improvement Project, and there will not be a clear delineation of road right-of-way for these two roads.

Recommendation:

The Department of Transportation recommends that the Board of Supervisors approve permission to advertise.
