Discussion/Action on the Pima County Attorney's Office request to utilize Anti-Racketeering Revolving Funds in support of Girl Scouts of Southern Arizona.

## \*Introduction/Background:

Funds are requested in the amount of \$2,100.00 for Girl Scouts of Southern Arizona.

#### \*Discussion:

This request is for Girl Scouts of Southern Arizona (GSSOAZ) Camp Fury. This is a high adventure immersion experience in the life of elite women of the police and fire services. It is a five-day, four-night experience, Girl Scouts ages 14-18 will join ranks of female law enforcement personnel and firefighters to learn hot they ensure public safety for our communities. Girl Scouts will practice search and rescue skills, learn crime scene investigation techniques, and perform physical fitness drills-including rappelling down a six-story building, climbing a 100-foot ladder truck, investigating crime scenes, and riding along with driving instructors in a high-speed obstacle course. One hundred and eight girls have participated in Camp Fury program over the past five years and has proven ro provide overwhelmingly positive interactions between the girls and law enforcement personnel, and is a powerful "pre-recruiting" tool for the Tucson Police Department.

#### \*Conclusion:

Camp Fury is an open and inclusive program that is advertised on the GSSOAZ website, across many of its social media platforms. Representatives from police and fire departments also reach out to the wider community to recruit girls for the program reaching girls who attend Camp Fury are from underserved communities. The program directed towards girls who are facing the greatest challenges: girls in foster/kinship care; in or at risk of entering the juvenile justice system; girls from low-income communities and/or under-resourced schools; and girls with a mother who is incarcerated. This organization is committed to making the Camp Fury experience available to any girl who wants to attend.

The Pima County Anti-Racketeering Revolving Fund has been created by forfeiture of property that constituted the proceeds of crime or that was used or intended to be used to commit crime. **Use of the funds is restricted to law enforcement purposes,** however transfers to community-based programs, whose missions are supportive of and consistent with **a law enforcement** effort, policy, or initiative are permitted.

NOTE: A program may benefit the community generally, but still not qualify for Pima County Anti-Racketeering Revolving Fund funds. To qualify, a program must specifically involve law enforcement personnel or otherwise include specific content which extends or enhances the efforts of law enforcement in the community, such as assisting victims of crime, preventing crime including by providing programs for at-risk youth, deterring crime, rehabilitation of offenders, emergency response by law enforcement, protecting people and property from crime, reducing the effects of crime, etc.

Describe the community-based program for which funds are being sought and how the program benefits the community:

Girl Scouts of Southern Arizona's (GSSOAZ) Camp Fury is a high adventure immersion experience in the life of elite women of the police and fire services. In this five-day, four-night experience, Girl Scouts ages 14-18 join the ranks of female law enforcement personnel and firefighters to learn how they ensure public safety for our communities. By way of example, Girl Scouts practice search and rescue skills, learn crime scene investigation techniques, and perform physical fitness drills—including rappelling down a six-story building, climbing a 100-foot ladder truck, investigating crime scenes, and riding along with driving instructors in a high-speed obstacle course. One hundred and eight (108) girls have participated in the Camp Fury program over five years.

Specifically, what law enforcement effort, policy, and/or initiative of this agency does this program support in this community?

The International Association of Chiefs of Police has published a guide entitled "Practices in Modern Policing: Police Youth Engagement." It states that more than four million youth who are 16 and 17 years old have face-to-face interactions with law enforcement each year: However, while research finds that positive interactions with police are predictive of positive attitudes toward the police, negative interactions are predictive of negative attitudes. (www.theiacp.org) Closer to home, the national 30x30 initiative has been embraced by the Tucson Police Department, which is working to have 30% of women in their ranks sworn in 2030.

Describe in detail how this program is supportive of and consistent with this law enforcement agency's efforts, policies, and/or initiatives in the community. What elements of the program specifically enhance or extend the efforts of law enforcement in the community, and how does the program do this?

The Camp Fury program has proven to provide overwhelmingly positive interactions between the girls and law enforcement personnel, and is a powerful "pre-recruiting" tool for the Tucson PD. Its unique design allows for a "brave space" for girls to push themselves both physically and mentally, in ways they may never have before. Because of the daily presence and active participation of all the female law enforcement and fire professionals, mutual admiration and respect grows between them and the girls. The girls take these experiences back to their schools, families, and the wider community, becoming de facto advocates for law enforcement.

As specifically as possible, please indicate how the funds requested will be used by this program (that is, to purchase supplies, equipment, and/or services; covering costs of participants or attendees; etc. **Direct cash transfers or gifts are not permitted**):

Funds will be used to replace (and expand) the equipment needed to operate the program. GSSOAZ consults with local professionals from each partner agency, along with Camp Fury co-founders, retired Fire Chiefs Cheryl Horvath and Laura Baker, to ensure we have the proper equipment to run the program safely. Equipment purchase is the main cost driver of this program. Another major cost is the transportation we provide to and from our Hacienda Program Center and the Public Safety Academy. We are able to operate such an extensive and multi-faceted program on a very lean budget due to the extraordinary volunteer efforts of our police and fire department representatives, at all levels. Our program staff is also integral to the success of the program. GSSOAZ underwrites these personnel costs through our general operating funds, which remain robust.

Please describe how your initiative will directly assist people from underserved communities and/or those who have been marginalized by a conviction history:

Camp Fury is an open and inclusive program. We advertise the program on the GSSOAZ web site, and across our many social media platforms. As mentioned above, representatives from police and fire departments also reach out to the wider community to recruit girls for the program. Because of this, we know that there are girls who attend Camp Fury that are from underserved communities. Also, GSSOAZ's Staff-Supported Program is directed towards girls who are facing the greatest challenges: girls in foster/kinship care; in or at risk of entering the juvenile justice system; girls from low-income communities and/or under-resourced schools; and, girls with a mother who is incarcerated. Our organization is committed to making the Camp Fury experience available to any girl who wants to attend.
