AMENDMENT
WHEREAS, Pima County ("County") and Santa Cruz County ("Santa Cruz") have entered into an Intergovernmental Agreement ("Agreement") to provide employment and training services; and

WHEREAS, the Contract is funded from a grant that County received from the U.S. Department of Labor ("DOL") to administer a H1-B Technical Skills Training Program ("H1-B Grant"); and

WHEREAS, the H1-B Grant is effective through November 30, 2015; and

WHEREAS, County is authorized to provide services and distribute existing grant funding through November 30, 2015; and

WHEREAS, Santa Cruz's performance was reviewed and found to be satisfactory; and

WHEREAS, the current economic welfare of Pima County indicates extending the use of Santa Cruz's services is in the best interests of the inhabitants of the County; and

WHEREAS, the parties agree to extend the term of the Agreement to continue to provide services.

NOW, THEREFORE IT IS AGREED TO AMEND THE AGREEMENT AS FOLLOWS:

ARTICLE I – TERM/EXTENSION, shall be amended to extend the term by replacing the paragraph with the following:

This Agreement, as awarded by County, shall commence on July 1, 2010 and shall terminate on June 30, 2014, unless sooner terminated or further extended pursuant to the provisions of this Agreement. The County shall have the option to renew this Agreement for up to an additional 6 months, if the conditions of the grant funding and Santa Cruz's performance so warrants.

All other provisions of this Agreement, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.
