RESOLUTION NO. 2013 - \_\_\_\_, A resolution of the Pima County Board of Supervisors, permitting the intermittent, temporary closure of Snyder Road in Pima County, Arizona, for the annual El Tour De Tucson on November 23, 2013. Staff recommends **APPROVAL**. (District 1)

The reason for this Resolution is that the Perimeter Bicycling Association of America, Inc., requests permission to intermittently, temporarily close Snyder Road from Sabino Canyon Road to Hidden Valley Road and Palisade Drive to Bear Canyon Road for an annual bicycle race. The street closure shall occur on Saturday, November 23, 2013, from 8:00 A.M. to 4:00 P.M.

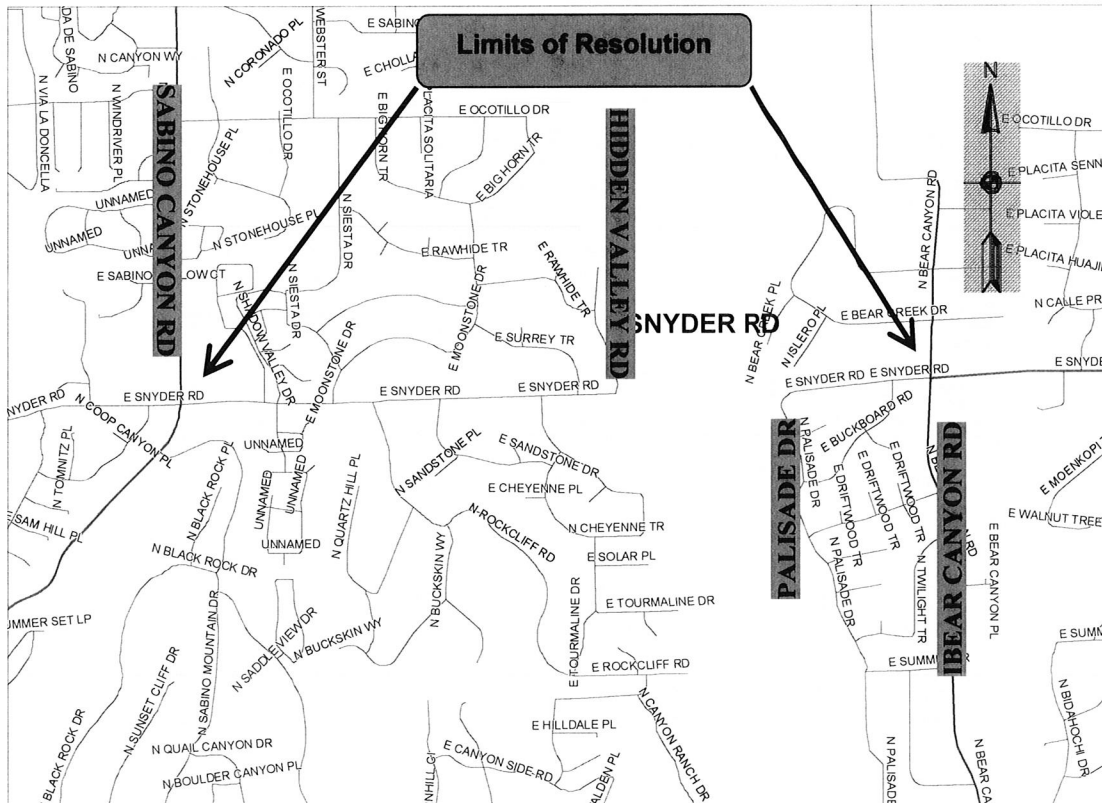


