ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors, regulating parking on Wade Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 3)

The reason for this ordinance is to regulate parking on Wade Road to provide added visibility of pedestrians and reduce congestion in the vicinity of the Academy del Sol School.

Pursuant to the Arizona Department of Transportation Guidelines for "Traffic Safety for School Areas," it is recommended that Wade Road be regulated No Stopping, Standing, or Parking on both sides of Wade Road from 500 feet south of Valley Crest Place to 500 feet north of Valley Crest Place in the vicinity of Academy Del Sol School. The No Stopping, Standing, or Parking signs have already been installed in the interest of public safety.

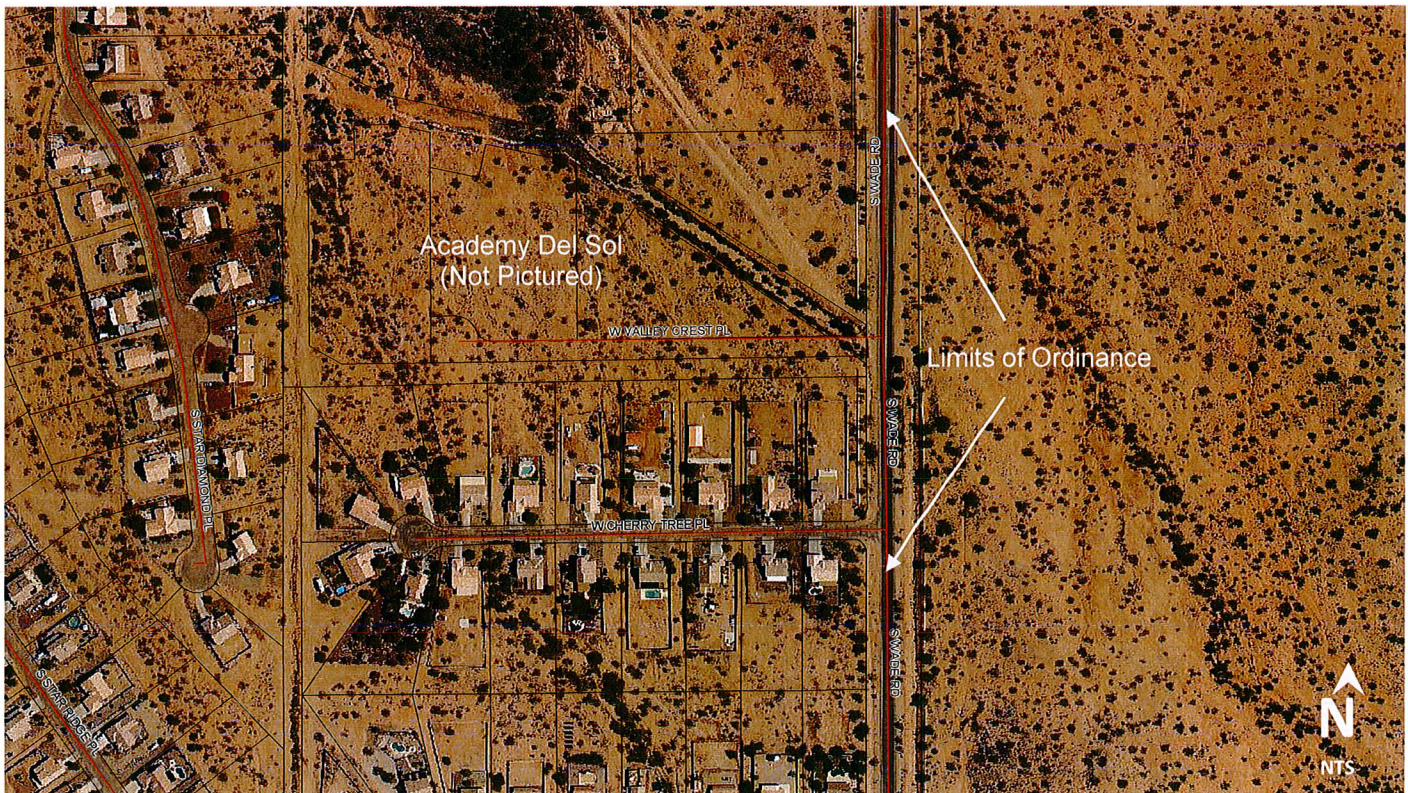

**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING PARKING ON WADE
ROAD IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not stop, stand or park on certain portions of Wade Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on both sides of Wade Road from 500 feet south of Valley Crest Place to 500 feet north of Valley Crest Place in the vicinity of Academy Del Sol School shall be regulated No Stopping, Standing, or Parking.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
