Dear Clerk of the Board of Supervisors,

Please submit my remarks for the record:

I as a member of Pima County, am urging the Supervisors to vote "no" for approving the \$1.5 million contract with Tenex Software Solutions for the cloud-based voting (E-pollbook and voting centers).

Internet connectivity must remain unbroken at all times on election day for these e-poll books to function effectively. There is no evidence this kind of Internet connectivity can be assured in rural areas, on tribal lands, or in under served communities within the Tucson metro area. Many times, I lose connectivity in my own home in Precinct 121.

Without doing a "practice run" before any election, especially the 2022 election with so many important statewide offices at stake is irresponsible. This is a shameful implementation of a process we have no idea how secure and effective it will be.

This is a non-partisan issue and a great concern to many in the community regardless of political party. I for one am concerned that Tenex Corporation has less than 20 employees yet its website states they "serve" more than 32 million American voters. This kind of top-down control of our elections process by a private corporation is taking us in the wrong direction to ensure a safe and fair voting system for people in all political parties.

I plead with all of the County Supervisors to vote "NO" on approving the \$1.5 million contract with Tenex Software Solutions.
