<u>Priority No. 3</u>: Develop County and public facing communication strategies to enable individuals to understand where and how to access information and resources.



PIMA COUNTY HOMELESS ENCAMPMENT FAQS

What is a homeless encampment? A homeless encampment is a temporary arrangement of tents, lean-tos or pallet structures on public or private land where two or more individuals experiencing homelessness reside. How do I report a homeless encampment? To report a homeless encampment not on private property, you can dial 3-1-1 or by using the County/City of Tucson Homeless Reporting Tool. How do I report trespassing on my property? Call 9-1-1. What if an encampment is abandoned but trash and other items were left behind? Report the abandoned encampment by dialing 3-1-1 or by using the County/City of Tucson Homeless Reporting Tool. What happens after I report a homeless encampment? Pima County will address homeless encampments on county-owned/maintained property or a rightof-way per the Pima County Homeless Encampment Protocol. Reported homeless encampments on privately owned property within unincorporated Pima County will be referred to the Pima County Department of Environment Quality to investigate/address. When should I call 9-1-1? You should call 9-1-1 if you see someone: · Whose behavior indicates they may be in medical distress · Who is unresponsive · Who is exhibiting threatening actions, or · Who is trespassing onto private property Who do I call when I or someone I know is experiencing homelessness? If you or someone you know is at-risk of or actively experiencing homelessness, you can call 3-1-1 or the


