Title: Sweetwater Drive No Stopping, Standing or Parking

Introduction/Background:

The reason for this ordinance is to establish portions of Sweetwater Drive as No Stopping, Standing or Parking in the vicinity of Robins K-8 School.

Discussion:

Pima County Traffic Engineering staff observed vehicular activity in the vicinity of Robins K-8 School. Vehicles were observed parking in the right-of-way along the south side of Sweetwater Drive in front of the school. These parked vehicles created a sight distance obstruction for vehicles exiting the school from Willemite Drive. The School was notified that Pima County Traffic Engineering would be installing signs to prevent stopping, standing or parking along Sweetwater.

Conclusion:

Pima County Traffic Engineering recommends portions of Sweetwater Drive be established as No Stopping, Standing or Parking based on field observations by staff to improve the sight distance for vehicles exiting Robins K-8 School from Willemite Drive.

Pima County Traffic Engineering recommends the south side of Sweetwater Drive from 250 feet west of Willemite Drive to 215 feet east of Willemite Drive be established as No Stopping, Standing or Parking.

ORDINANCE NO. 2016-___

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS REGULATING PARKING ON SWEETWATER DRIVE IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park on the south side of Sweetwater Drive from 250 feet west of Willemite Drive to 215 feet east of Willemite Drive,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on the south side of Sweetwater Drive from 250 feet west of Willemite Drive to 215 feet east of Willemite Drive shall be regulated No Parking, specifically No Stopping, Standing or Parking.

SECTION 2. Any ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
