**Title:** Flood Control District Advisory Committee Appointment

### Introduction/Background:

On February 23, 1988, the Pima County Board of Supervisors (Board), sitting as the Board of Directors of the Pima County Flood Control District established the Flood Control District Advisory Committee (FCDAC). The FCDAC consists of one appointment from each Board district and each incorporated jurisdiction.

### Discussion:

E. Linwood Smith represented the City of Tucson (City) on the FCDAC. Mr. Smith retired on September 30, 2015. The City has requested that Kieran Sikdar replace Mr. Smith on the FCDAC.

### Conclusion:

Currently, the City does not have representation on the FCDAC; therefore, the District is requesting the Board of Supervisors ratify Kieran Sikdar's appointment to the FCDAC.
