# **EOC Objectives and Points of Incident Command Emphasis**

- Finalize plan for infection of response staff by Wednesday, April 8th
- Develop and implement an ordering, receiving, and distribution plan for all materials and affected entities, including PPE by Friday, April 10th
- Develop and implement staffing resource tool by Friday, April 10th
- Identify a process (recruitment, training, placement) for medical volunteers by Friday, April 10th
- Assess non-emergent transportation capacity by Friday, April 10th
- Maintain support of Pima County testing capability
- Coordinate with health care system leadership for local surge strategy
- Provide for the safety of responders, health care providers, and the community by following established safety protocols, by conducting risk management assessments, and by establishing regular communications with cooperators.
- Provide relevant and/or critical information to cooperators in a timely manner to allow for safe and efficient operations
- Provide information to the public and media as it becomes available throughout the day, including critical notifications as necessary
- Create a recovery process that aligns with the multiple local, state, national disaster declarations

What the public is talking about:

- Overall support for Gov. Ducey's out-of-state restrictions
  - o Some think there needs to be a way to enforce this like no airline flights, border crossing checks, etc.
- City of Tucson form to report people violating Gov. Ducey's executive order is popular
- People are pushing for disclosure of locations of positive cases to help contain the spread
  - o Ironically, these comments have gotten worse since Dr. Bob's video explaining why it's misleading to do this.
- More questions about overall testing. People find it hard to believe there's still a limited supply as compared to other parts of the country/state.
