



# Board of Supervisors Memorandum

January 21, 2014

## Aerospace Parkway Establishment – REVISED

### Introduction

The Board of Supervisors approved an economic development plan aimed at protecting the region's most significant employers. Part of that plan is to protect and buffer Raytheon from urban encroachment. The County purchased 382 acres for an approximately \$6 million to accomplish the first phase of the plan.

The second phase of this plan is to relocate Hughes Access Road, allowing for significant operating/expansion buffer for Raytheon. In the future, this relocated roadway will be renamed the Aerospace Parkway, which will be integrated with a larger economic development proposal related to attracting primary employment in the aerospace, defense, and manufacturing sectors, designed to attract technology and high-wage employers.

The official road establishment is necessary by the County as a first step in officially relocating the roadway. The establishment proceedings will allow the County to take the steps necessary to acquire rights of way, of which 37 acres are County-owned, 51.72 acres are owned by the Tucson Airport Authority, and 4.5 acres are owned by the City of Tucson. Establishment essentially signals the County's legal intent to create the roadway and allows all other necessary actions to occur, including right of way acquisition by purchase, negotiation, or condemnation and construction of the relocated roadway.

### Recommendation

I recommend the Board of Supervisors approve advertisement of a February 18, 2014 public hearing date for Roadway Establishment No. 3018 to establish a new roadway to substitute for Hughes Access Road, which shall be known as the Aerospace Parkway. I further recommend that, following discussion and input at the February 18, 2014 public hearing, the Board approve Roadway Establishment No. 3018.

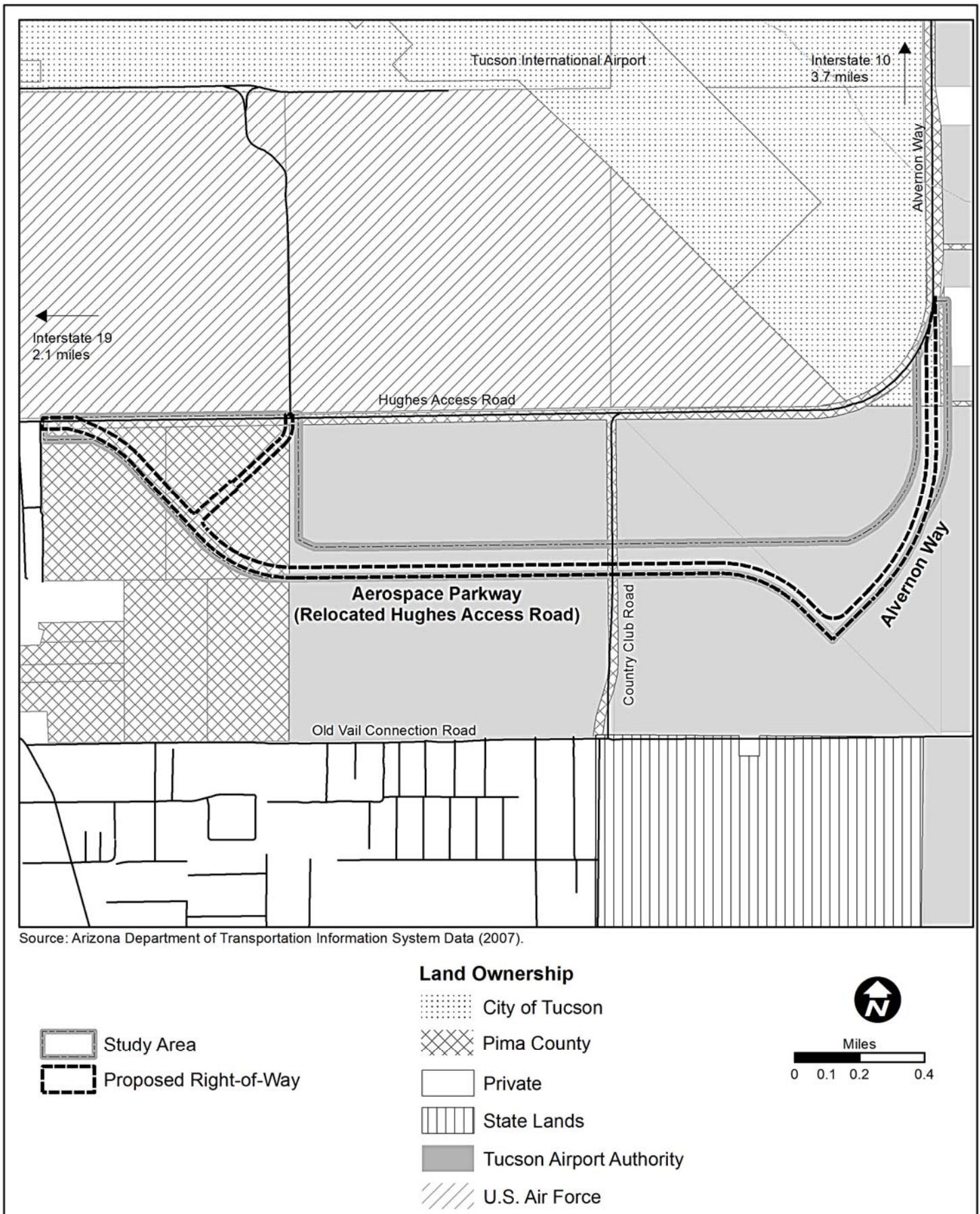


Figure 1. Project Vicinity Map

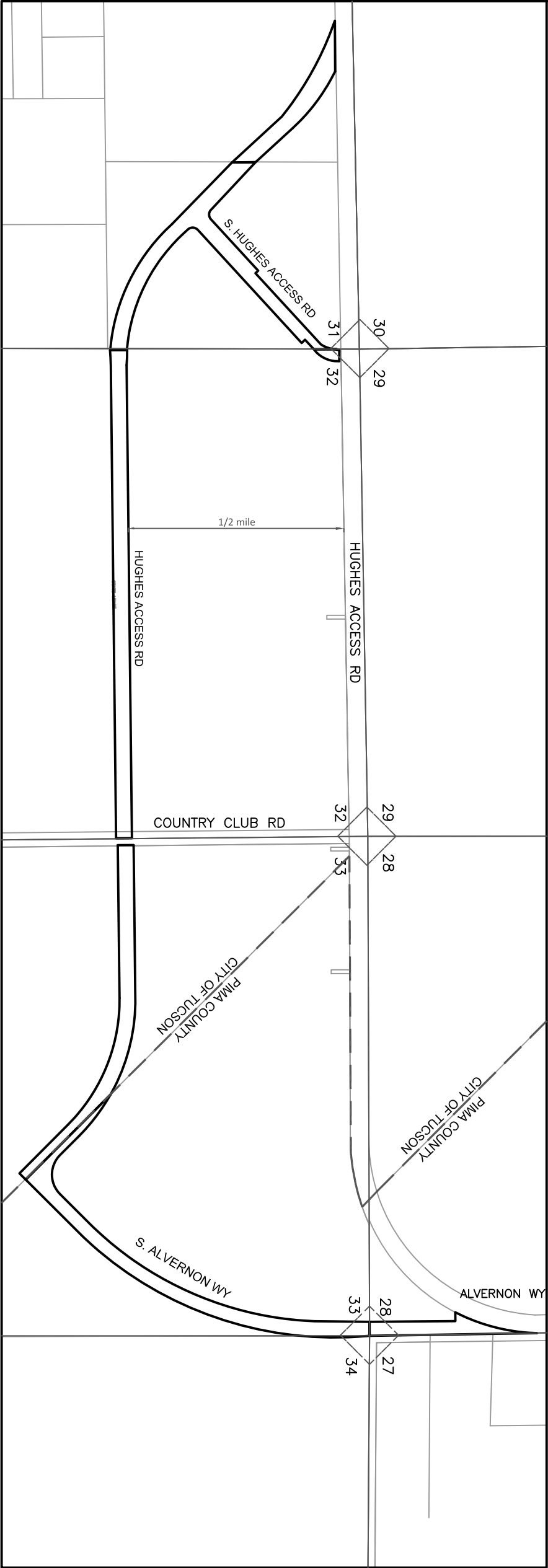
