Amendment of Award: Master Agreement No. MA-PO-22-026, Amendment No. 09. This Amendment extends the termination date to 08/15/2024. No additional funds are required at this time. Administering Department: Fleet Services

*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.060, Emergency and other limited competition procurement, on 08/13/2021, the Procurement Director approved an award of contract for an initial term of six (6) months in the not-to-exceed award amount of \$250,000.00 with four (4) six-month renewal options.

Effective 02/16/2022, the Procurement Officer processed Amendment No. 01, which extended the termination date to 08/15/2022. No additional funds were added and the contract not-to-exceed amount remained at \$250,000.00. Three (3) six-month renewal options remained.

On 04/19/2022, the Board of Supervisors approved Amendment No. 02, which increased the award amount by \$250,000.00 for a cumulative not-to-exceed contract amount of \$500,000.00.

On 07/29/2022, the Procurement Director approved Amendment No. 03, which extended the termination date to 02/15/2023. No additional funds were added and the contract not-to-exceed amount remained at \$500,000.00. Two (2) six-month renewal options remained.

On 12/20/2022, the Board of Supervisors approved Amendment No. 04, which increased the award amount by \$525,000.00 for a cumulative not-to-exceed contract amount of \$1,025,000.00 and added the Forced Labor of Ethnic Uyghurs provision to the contract.

On 02/08/2023, the Procurement Director approved Amendment No. 05, which extended the termination date to 08/15/2023. No additional funds were added and the contract not-to-exceed amount remained at \$1,025,000.00. One (1) six-month renewal option remained.

On 06/29/2023, the Procurement Director approved Amendment No. 06, which was for a one-time increase in the amount of \$500,000.00 for a cumulative not-to-exceed contract amount of \$1,525,000.00 pursuant to Procurement Code 11.12.060, Emergency and other limited competition procurement and the Emergency Procurement Authorization – Title 42 Rescission and Southwest Border Asylum Seeker Surge signed by the County Administrator on 12/04/2022, which granted approval to the Procurement Director to waive normal procurement practices and make emergency procurements of materials and/or services to support the surge of asylum seekers once Title 42 was lifted.

On 08/15/2023, the Procurement Director approved Amendment No. 07, which extended the termination date to 02/15/2024. No additional funds were added and the contract not-to-exceed amount remained at \$1,525,000.00.

On 09/21/2023, the Procurement Director approved amendment No. 08, which was for a one-time increase in the amount of \$350,000.00 for a cumulative not-to-exceed contract amount of \$1,875,000.00 pursuant to Procurement Code 11.12.060, Emergency and other limited competition procurement and the Emergency Procurement Authorization – Title 42 Rescission and Southwest Border Asylum Seeker Surge signed by the County Administrator on 12/04/2022, which granted approval to the Procurement Director to waive normal procurement practices and make emergency procurements of materials and/or services to support the surge of asylum seekers once Title 42 was lifted.
